Section 214 *et. al.* (1982), and Section 63.18 of the Federal Communication Commission's (hereafter called “Commission”) Rules, 47 C.F.R. Section 63.18, to provide global or limited international facilities-based and resale services between the United States and international points, except those international points not authorized by the Commission and updated from time to time on the Commission’s Exclusion List. **My Fi LLC**, is a U.S. company organized under the laws of the **State of Florida** to provide international telecommunications services. **My Fi LLC** has no foreign affiliations.
