Licensee is non-dominant with respect to the services being discontinued. No end-user customers or resale carriers were served by the Licensee under ITC-214-20140806-00234 after the Commission's grant of authority on May 28, 2015. MY FI LLC has since ceased all business operations and will not offer services in the future.

47 C.F.R. § 63.19 Compliance:

Pursuant to 47 C.F.R. § 63.19, if MY FI LLC. is required to give notice to all affected customers of the planned discontinuance it shall be at least 60 days prior to its planned action. No carriers, customers or subscribers were serviced by MY FI LLC to require notice pursuant to 47 C.F.R. § 63.19. Had this been so required, each affected customers/carriers of the Licensee would have received notice in compliance of the Rule as found in Exhibit 1.

Regulatory Fee Liability Statement:

MY FI LLC has <u>not</u> petitioned for Bankruptcy Protection under U.S. Federal or State Bankruptcy Protection, and does not intend to do so within the next consecutive ninety (90) calendar days. No telecommunications revenues were realized by Licensee since May 28, 2015. The Licensee certifies, by and through their undersigned corporate officer that it been to the contrary, it would have made arrangements to pay regulatory fees outstanding to the Commission and has reviewed the FCC CORES system to identify no regulatory fees outstanding. Presently, no debt to the Commission is outstanding with the company.

Licensee understands that delinquent telecommunication contributors/debtors fall under the Commission's "red light rule" and that the red light rule requires the Commission to withhold action on applications and other requests for benefits when the Entity applying for or seeking benefits is delinquent in non-tax debts owed to the Commission, and to dismiss such applications or other request if the delinquency is not resolved. Licensee understands that the failure to pay all outstanding regulatory fees may result in either withhold of action or dismissal of this application by the Commission. Again, no debt to the Commission is outstanding with Licensee as no telecommunications revenues were realized by the company.

Licensee hereby certifies that it has notified and submitted a copy of this application to surrender authority to the Secretary of Defense and Team Telecom; no such requirement was applicable to the state PUCs; and the governors of the states in which service will be affected, as required by law and regulation based upon the Licensee's service and service areas.
