**ITC-214-20140825-00253 (e-file)**

Danale Inc.'s application for authority to provide Resale Service between the United States and permissible international points. Applicant is 100% owned by a **Chinese** company.

**ITC-214-20140828-00254 (e-file)**

Tismi Wireless, LLC's application for authority to provide Resale Service between the United States and permissible international points. Applicant is 100% owned by a **Netherlands** company which is indirectly and equally owned by two citizens of **the Netherlands**.
