Section 63.18, to provide global or limited international facilities-based and resale services between the United States and international points, except those international points not authorized by the Commission and updated from time to time on the Commission’s Exclusion List. **Global Freedom Telecom LLC**, is a U.S. company organized under the laws of the **State of Florida** to provide international telecommunications services.
