Pursuant to 63.10(a)3, the applicant's affiliated company, Callmonitor Limited (registered in England & Wales, registration number 03844878) does not operate or do business in the international transport or local access markets in the United Kingdom or any other country or market and therefore should be classified as non-dominant.

Question 12
