ITC-214-20150521-00132 (e-file)

Imecom Group, Inc.'s application for authority to provide Facilities-Based and Resale Services between the United States and permissible international points. Applicant is 100% owned by a **Spanish** company which is in turn 99% owned by a **French** publicly traded company.

ITC-214-20150518-00124 (e-file)

USA VoIP LLC's application for authority to provide Facilities-Based and Resale Services between the United States and permissible international points. Applicant is 100% owned by a citizen of **Spain**.

Selectel, Inc. requests consent to the transfer of control of section 214 authorization, ITC-214-20090326-00133, from Matthew S. O'Flaherty, Teri L. O'Flaherty, and Stacy Hergentrader. to Compass Atlantic Inc. Compass Atlantic Inc. is a wholly-owned subsidiary of Compass Capital Inc. which is organized under the law of **Canada** and 70% owned by a citizen of **Canada**.
