

## **Attachment B**

- (f) At this time, Applicant does not seek authority to provide service not referenced under paragraph (e) of Section 63.18 of the Commission’s Rules. 47 C.F.R. §63.18 (e).
- (g) CallFire will use previously authorized facilities to provide the services requested by the Application. Consequently, CallFire is categorically excluded from environmental assessment pursuant to Section 1.1306 of the Commission’s Rules. 47 C.F.R. §1.1306.
