Cuba International Network (CIN) is a start-up Florida LLC. Its sole member is Mr. Barry Pasternak, a U.S. citizen who lives at 2158 Nova Village Drive, Davie, Florida, 33317. Mr. Pasternak has a 40 year history in the broadcast and telecommunications businesses.

Since 1992, Mr. Pasternak has been President of BHP Consultants, a media consulting firm that manages broadcast and multimedia events, ensures multiplatform and multiscreen network delivery, provides content development, delivery and broadcast production services, designs telecom networks and provides strategic planning to media companies. His current clients include NBC and ESPN for their delivery of the 2016 Olympics. (A copy of his full resume is attached hereto.)

Mr. Pasternak was a principal in the following four companies that were previously granted FCC 214 licenses approximately in the years indicated below:


