Response to Question 14

Syringa Networks, LLC (“Syringa”) is a limited liability company organized under the laws of Idaho. Syringa has not previously received a Section 214 authorization. There are no interlocking directorates with a foreign carrier.

The following entities are owners of Syringa:

1. **Albion Telephone Company** – Albion Telephone Company holds an 11.97% interest in Syringa. Darla Redman holds a 56% interest in Albion Telephone Company. Darla Redman is a U.S. citizen whose mailing address is PO Box 98, Albion, ID 83311. No other shareholder in Albion Telephone Company holds an indirect ownership interest in Syringa of 10% or more.

3. **Filer Mutual Telephone Company** – Filer Mutual is organized as a rural telephone cooperative that is wholly owned by its member customers. No individual member holds a direct interest of 10% or more in Filer Mutual. Accordingly, no individual member customer holds an indirect ownership in Syringa of 10% or more.

4. **Horizon Communications, Inc.** – Horizon Communications holds an indirect 11.04% interest in Syringa through two wholly-owned subsidiaries, Silver star Telephone Company, Inc. d/b/a Silver Star Communications (2.52%), a Wyoming corporation, and Gold Star Communications, LLC (8.52%), a Wyoming limited liability company. Both Silver Star and Gold Star are wireline/wireless telecommunications companies, respectively. The address for Silver Star and Gold Star is PO Box 226, Freedom, WY 83120. The following entities hold direct ownership interests in Horizon Communications, Inc.

The controlling interest in Horizon is held by Cedar Creek Investments L.P. ("Cedar Creek"), a Wyoming limited partnership. The general partnership interests in Cedar Creek are held indirectly by the Allen R. Hoopes Revocable Trust and the Jamielyn H. Hoopes Revocable Trust in equal shares through Cedar Creek Management LLC, a Wyoming limited liability company. The limited partnership interests in Cedar Creek are also held directly in equal shares by the Allen R. Hoopes Revocable Trust and the Jamielyn H. Hoopes Revocable Trust. Allen R. Hoopes is the trustee and beneficiary of the Allen R. Hoopes Revocable Trust and his wife, Jamielyn H. Hoopes, is the trustee and beneficiary of the Jamielyn H. Hoopes Revocable Trust. The address for those entities and individuals is PO Box 226, Freedom, WY 83120. Allen R. Hoopes and Jamielyn H. Hoopes are both U.S. citizens.

Hoopes Telephone Management L.P. ("HTM"), an Idaho limited partnership, holds a 73% non-voting interest in Horizon Communications. Cedar Creek is a general partner of HTM and holds a 4.46% interest in HTM. Limited partners of HTM are as follows:

Allen R. Hoopes, a U.S. citizen, is trustee of the Allen R. Hoopes Descendants Trust.

The ESOP Trust holds the remaining 20% nonvoting interest in Horizon. The trustee of the ESOP Trust is Kenneth J. Cummins, a U.S. citizen.

4. **Project Mutual Telephone Cooperative Association** – Project Mutual is organized as a rural telephone cooperative that is wholly owned by its member customers. No individual member holds a direct interest of 10% or more in Project Mutual. Accordingly, no individual member customer holds an indirect ownership in Syringa of 10% or more.

Response to Question 15:

Syringa has not previously received authorization under section 214 of the Act to provide international services. By this application, Syringa is requesting authority to operate as an international resale carrier pursuant to section 63.18(e)(2) of the Commission's rules. At this time, Syringa is not requesting authority to operate under sections 63.18(e)(1) or (e)(3) of the Commission's rules. Accordingly, the provisions of section 63.18(g) are not applicable.
