CubaMobile, LLC (hereinafter "CubaMobile")¹ hereby notifies the Federal Communications Commission that it agrees to accept the terms and conditions for the waiver of the benchmark rate applicable to Cuba as specified in the Commission's TeleCuba Waiver Order² and International Settlements Policy Reform Order.³ CubaMobile submits the enclosed certification in support of this notification.




