Application of Rebtel Networks AB for Authority to Provide International Facilities-Based and Resold Telecommunications Services to All International Points

Answer to Question 9:

This application qualifies for streamlined processing pursuant to Section 63.12 of the Commission's rules, 47 C.F.R. § 63.12. As further described below in response to Question 11, Rebtel Networks AB ("Rebtel") is a foreign carrier in Sweden and is affiliated with certain foreign carriers in Australia, Austria, Canada, Luxembourg, the Netherlands, and Poland. Each of these countries is a member of the World Trade Organization ("WTO"). Moreover, Rebtel is presumptively non-dominant on the international routes between the U.S. and these countries because it and its foreign carrier affiliates: (1) do not own any telecommunications facilities, (2) are not monopoly providers of communications services, and (3) lack 50 percent market share in the international transport and local access markets, in their respective foreign destination markets.

Answer to Question 11:

Rebtel provides the following information and certifications as required in Sections 63.18(i) through (m) of the Commission's rules, 47 C.F.R. §§ 63.18(i)-(m):

- (i) Rebtel certifies that it is a foreign carrier in Sweden and that it is affiliated with foreign carriers in Australia, Austria, Canada, Luxembourg, the Netherlands, and Poland.
- (j) Rebtel certifies that it seeks authorization to provide international telecommunications services to all international points, including the destination countries in which it is a foreign carrier or is affiliated with foreign carriers. Specifically, Rebtel is a foreign carrier in Sweden and it is affiliated with the following foreign carriers:
 - Rebtel Poland Sp.z.o.o. (authorized in Poland)
 - Rebtel Services Sa.r.l. (authorized in Australia, Austria, Canada, Luxembourg, and the Netherlands)
- (k) Australia, Austria, Canada, Luxembourg, the Netherlands, Poland, and Sweden are WTO member countries. Rebtel and each of its foreign carrier affiliates lacks market power in the foreign countries in which it operates.
- (l) Not applicable.
- (m) With respect to the international routes between the United States and the foreign countries listed above, Rebtel is presumptively non-dominant under Section 63.10 of the Commission's rules, 47 C.F.R. § 63.10, because it and its foreign carrier affiliates: (1) do not own any telecommunications facilities, (2) are not monopoly providers of

communications services, and (3) lack 50 percent market share in the international transport and local access markets in their respective foreign destination markets.

Answer to Question 12:

As set forth above, Rebtel seeks authorization to provide telecommunications services on the routes between the U.S. and the foreign countries set forth in response to Question 11 above.

Answer to Question 14:

Rebtel Networks AB ("Rebtel") is a wholly-owned direct subsidiary of New Rebtel AB ("New Rebtel"), a private limited company organized under the laws of Sweden. The principal business of New Rebtel is holding company, and its address is Jakobsbergsgatan 16, SE-111 44, Stockholm, Sweden.

Rebtel Holding AB ("Rebtel Holding") holds approximately 61.8 percent of the equity of New Rebtel. Rebtel Holding is a private limited company organized under the laws of Sweden, and its principal business is holding company. Its address is Jakobsbergsgatan 16, SE-111 44, Stockholm, Sweden.

Certain management and key personnel of Rebtel collectively hold approximately 38.2 percent of the equity of New Rebtel. Mangus Larsson, Rebtel's chief executive officer, holds approximately 12 percent of the equity of New Rebtel. Mr. Larsson is a Swedish citizen, and his address is Vattugatan 6, 172 73 Sundbyberg, Sweden. No other employees individually hold ten percent or more of the equity of New Rebtel.

Rebtel Holding is a wholly-owned direct subsidiary of Rebtel Owners AB ("Rebtel Owners"), a private limited company organized under the laws of Sweden. The principal business of Rebtel Owners is holding company, and its address is Jakobsbergsgatan 16, SE-111 44, Stockholm, Sweden.

Hjalmar Winbladh, through his wholly-owned Swedish holding company FHW Holding AB, holds approximately 18.5 percent of the equity of Rebtel Owners. Mr. Winbladh is a Swedish citizen. The address for Mr. Winbladh and his holding company is Risvägen 48, 132 27 Saltsjö-Boo, Sweden.

Jonas Lindroth, through his wholly-owned Swedish holding companies Highwave Consulting AB and WindWave AB, holds approximately 16.3 percent of the equity of Rebtel Owners. Mr. Lindroth is a Swedish citizen. The address for Mr. Lindroth and his holding companies are Tomtebogatan 26a, 113 38 Stockholm, Sweden.

Index Venture Associates III Limited ("Index Venture Associates"), a venture capital firm, holds through various investment funds approximately 15.7 percent of the equity of Rebtel Owners. Of those investment funds, only Index Ventures III (Delaware) L.P. ("Index Ventures Delaware") holds ten percent or more (approximately 10.3 percent) of the equity of Rebtel Owners. Index Venture Associates is the general partner of Index Ventures Delaware. Index Venture Associates is formed under the laws of the Channel Islands. Index Ventures Delaware is formed under the laws of the state of Delaware. The following individuals are directors of Index Venture Associates: Ian Henderson, Nigel Greenwood and David Hall (all citizens of Great

Britain), Sinéad Meehan (a citizen of Ireland), and Bernard Dallé (a citizen of Switzerland). The address of these entities and individuals is P.O. Box 641, St. Helier Jersey, JE 8YJ Channel Islands.

Balderton Capital II, L.P. ("Balderton Capital") holds approximately 15.7 percent of the equity of Rebtel Owners. Balderton Capital Partners II, L.P. ("Balderton Partners") is the general partner of Balderton Capital. Balderton Capital General Partner II, L.L.C. ("Balderton General Partner") is the general partner of Balderton Partners. Balderton Capital, Balderton Partners, and Balderton General Partner are investment funds or holding companies, each is formed under the laws of the state of Delaware, and the business address for each is 2480 Sand Hill Road, Menlo Park, California 94025.

Rebtel Intressenter AB ("Rebtel Intressenter"), a private limited company organized under the laws of Sweden, holds approximately 11 percent of the equity of Rebtel Owners. Rebtel Intressenter is a special purpose vehicle associated with an employee incentive program and is owned by prior Rebtel employees, none of whom individually hold indirectly a ten percent or greater equity interest in Rebtel. Rebtel Intressenter's address is Saltsjökvarnskaj 35, 131 71 Nacka, Sweden.

To the best of Rebtel's knowledge, no other individual or entity holds directly or indirectly 10 percent or more of the equity of Rebtel.

Rebtel is not aware of any interlocking directorates with foreign carriers, except for interlocking directorates with carriers within the Rebtel group of companies.

Answer to Question 15:

Rebtel provides the following information as required in Sections 63.18(d), (e)(3) and (g) of the Commission's rules, 47 C.F.R. §§ 63.18(d), (e)(3), (g):

- (d) Rebtel has not previously received authority to provide international telecommunications services under Section 214 of the Communications Act.
- (e)(3) Because Rebtel is not applying for authority to acquire facilities or to provide services that are not covered by Sections 63.18(e)(1) and 63.18(e)(2) of the Commission's rules, this rule is not applicable.
