

## **Attachment 2 CERTIFICATE**

- (g) BryteCall will use previously authorized facilities to provide the services requested by the Application. Consequently, BryteCall is categorically excluded from environmental assessment pursuant to Section 1.1306 of the Commission's Rules. 47 C.F.R. § 1.1306.
- (h) With regarding to ownership, the following entities and people hold 10% or more of an ownership interest, directly or indirectly, in BryteCall:
