CERTIFICATE**

Vibratel, LLC (“Vibratel” or “Applicant”) provides the following information required by 47 CFR § 63.18(d)-(j) with respect to its Application for Authority to provide international telecommunications services:

- (f) At this time, Applicant does not seek authority to provide service not referenced under paragraph (e) of Section 63.18 of the Commission's Rules. 47 C.F.R. § 63.18(e).
- (g) Vibratel will use previously authorized facilities to provide the services requested by the Application. Consequently, Vibratel is categorically excluded from environmental assessment pursuant to Section 1.1306 of the Commission's Rules. 47 C.F.R. § 1.1306.
- (h) With regarding to ownership, the following people hold 10% or more of an ownership interest, directly or indirectly, in Vibratel:
