**Application for Authority**

Kiono Communications LLC ("Applicant," or "Kiono") hereby requests authority, pursuant to Section 214 and Section 63.18 of the Commission's Rules, 47 C.F.R. § 63.18, to offer global or limited international resale services between the United States and international points, except those international points not authorized by the Commission and updated from time to time on the Commission's Exclusion List. Applicant is a limited liability company organized under the laws of the State of California to provide international telecommunications services. Applicant has not previously applied for International Section 214 Authority from the Commission. Upon the grant of International Section 214 Authority, Kiono will serve customers throughout the United States. By granting this application, the Commission will serve the public interest by promoting competition in the international services market. This competition will benefit consumers by increasing service options and lowering prices. In support of this application, Applicant submits the following:


