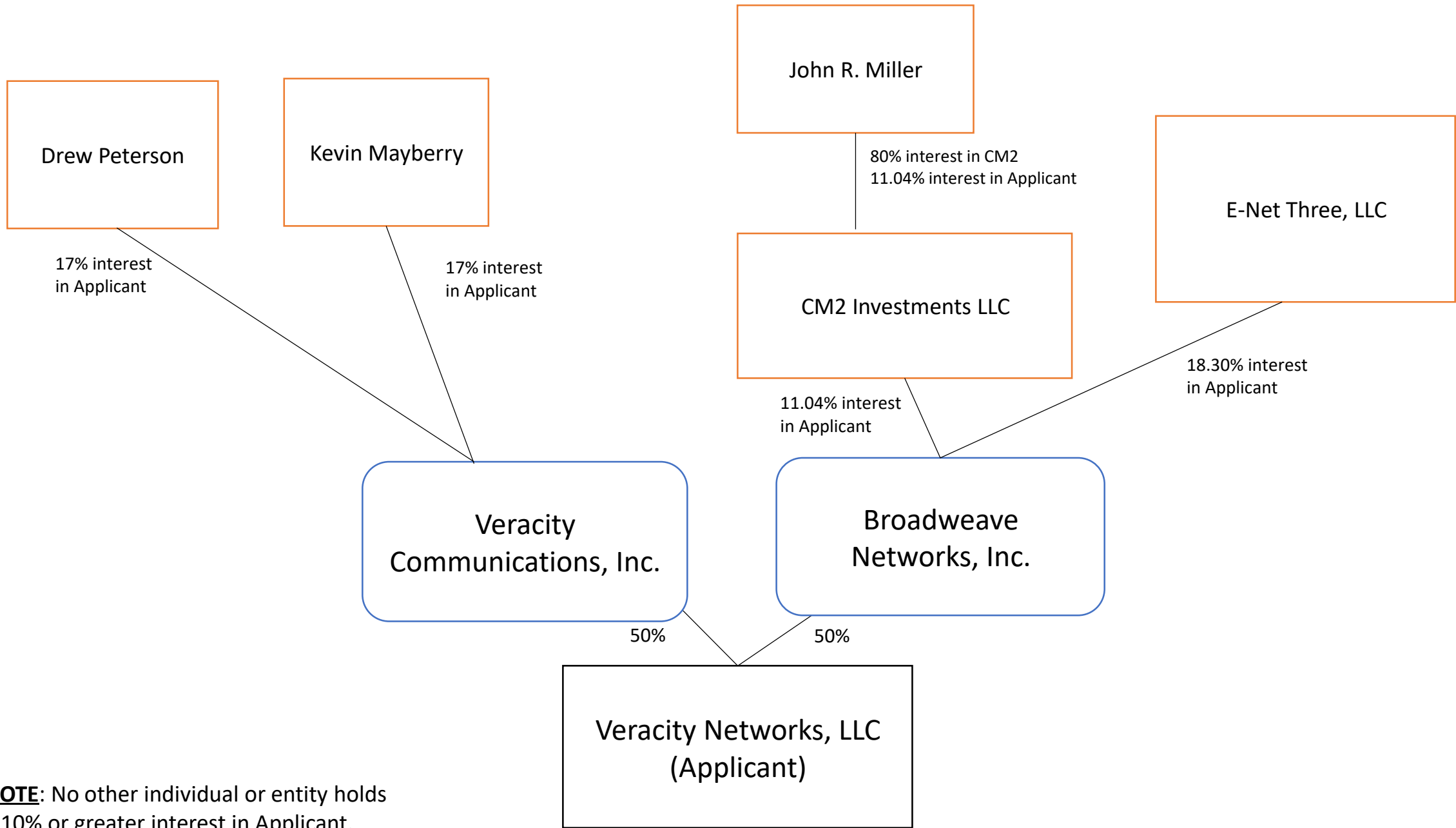
The applicant has not previously received international authority under Section 214 of the Act.
