Peter Adderton and Peter Hill are each on the board of Boost Mobile Australia and Mobile X Global, Inc.

Special Considerations

The applicant notes that two factors support prompt review of the above foreign ownership interests and approval of the global resale authority requested by this application.

Adderton Experience in U.S. Wireless Marketplace

First, Peter Adderton, the majority owner of the applicant, has played a significant and long-standing role in the mobile wireless marketplace in the United States. Peter Adderton is the driving force behind two of the most successful MVNOs ever established — Boost Mobile and Amp'd Mobile. These businesses created jobs for thousands of Americans and helped establish several thousand small independent wireless dealers.

Mr. Adderton founded Boost Mobile in Australia in 2000, and subsequently expanded it to New Zealand, Canada and the United States. Mr. Adderton catapulted the Boost brand to become one of the fastest growing wireless brands in its category with annual revenues over \$500M and more than five million subscribers. Under his leadership, Boost Mobile USA was purchased by Nextel in 2004, and remained a wholly owned subsidiary of Sprint Nextel until the April 2020 merger of Sprint and T-Mobile. Subsequently, Boost Mobile was sold to Dish Networking in July

2020. Boost Mobile remains one of the fastest growing mobile brands in its category with annual revenues of more than \$3 billion and approximately eight million subscribers.

In 2004, Mr. Adderton founded US-based Amp'd Mobile, creating the first integrated mobile entertainment company. While Amp'd Mobile is no longer in operation, its success as a brand and innovator in putting content on mobile devices is unquestionable—pioneering the concept of wireless carrier as mobile entertainment company.

More recently, Mr. Adderton has spent the past several years advocating tirelessly on behalf of wireless consumers, leading the drive for increased competition to put the wireless consumer in the driver's seat. He has met numerous times with the Chair and Commissioners, repeatedly helped brief the Antitrust Division of Department of Justice, and discussed telecommunications consumer issues with Members of Congress.

Finally, Mr. Adderton has lived in the United States as a permanent resident for more 20 years, and has three proud American daughters.

Australian Investment Presents No National Security Concerns

Second, review of this application should recognize the absence of any national security concerns arising from substantial telecom investments by Australian citizens. Australia has long-standing partnerships with the United States in the areas of defense, intelligence sharing, and trade policy. As evidence that Australia is a particularly trusted ally, in February 2020, the Committee on Foreign Investment in the United States (“CFIUS”) identified Australia as one of three “excepted foreign states” under the Foreign Investment Risk Review Modernization Act of 2018, exempting Australian investments from certain CFIUS filing requirements. Provisions Pertaining to Certain Investments in the United States by Foreign Persons, 85 Fed. Reg. 3112, 3116 (Jan. 17, 2020) (citing “robust intelligence sharing and defense industrial base integration mechanisms with the United States”).

Accordingly, the applicant requests that the Commission take into account Australia's general status with respect to United States national security and Mr. Adderton's specific status as a long-standing investor in the United States when reviewing this application.
