**Re: Update to Liberty Cablevision of Puerto Rico LLC Application for International
214 Authorization (ITC-214-20170323-00053)**

Dear Secretary Dortch:

Liberty Cablevision of Puerto Rico, LLC (“Liberty”) hereby updates its Application for International 214 Authorization (ITC-214-20170323-00053) currently pending before the Commission.¹ As a result of a *pro forma* transfer of control, control of Liberty has been transferred from Liberty Global plc to Liberty Latin America Ltd.²

The transfer of control of Liberty from Liberty Global plc to Liberty Latin America Ltd. is reflected in the attached updated corporate organizational chart, which updates Liberty’s response to question 14 in the International Section 214 Application.³ In response to Question 14, Liberty previously submitted a corporate organizational chart, and information related to its equity holders. For ease of review, Liberty has included its previous response to Question 14. 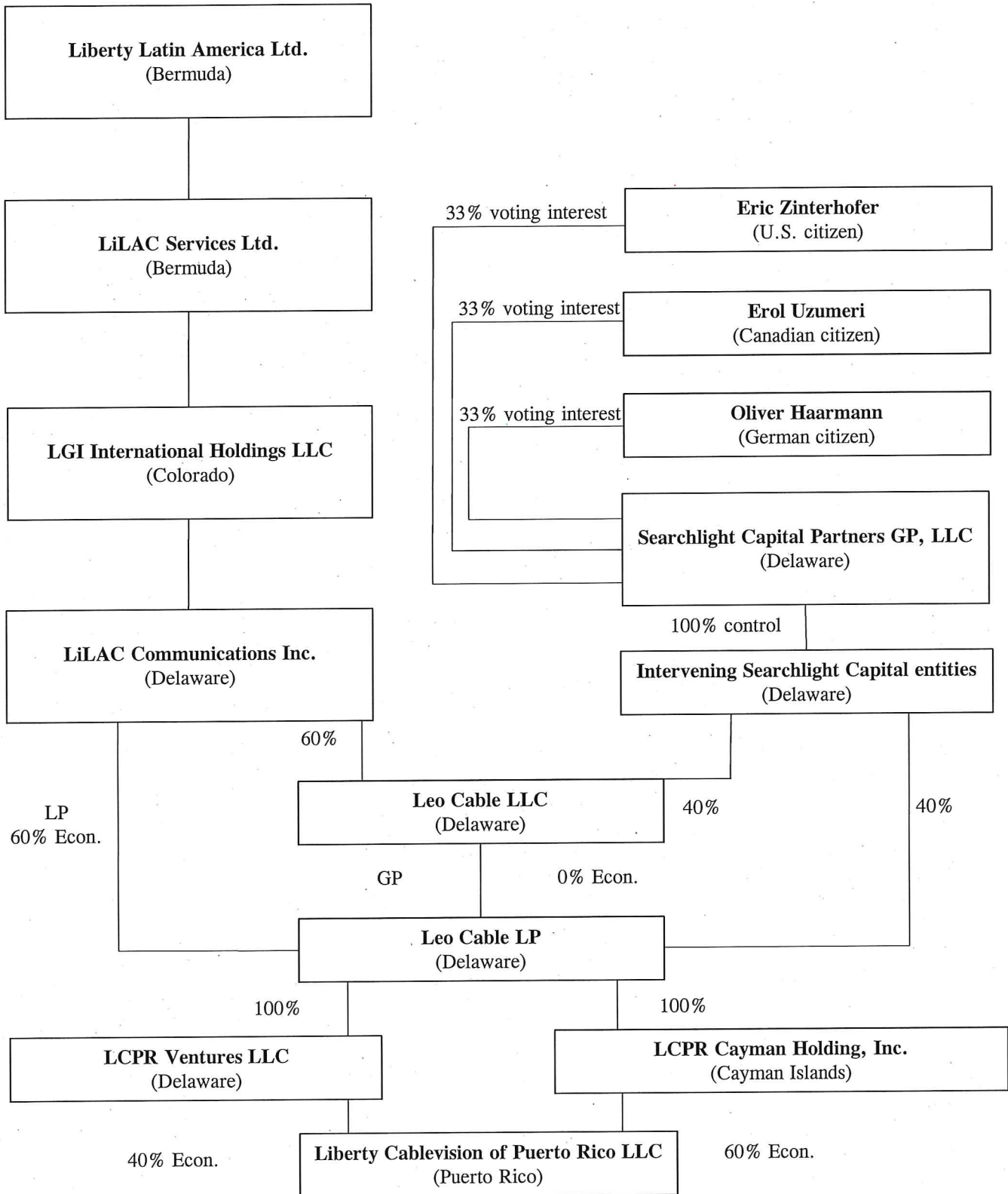
