Amendment to Notification of *Pro Forma* Transfer of Control of LKN Communications, Inc. and ACN Communication Services, LLC

LKN Communications, Inc. ("LKN") and ACN Communication Services, LLC ("ACN"), (jointly, "Parties") pursuant to 47 C.F.R. § 63.24(f), hereby notify the Commission of a *pro forma* transfer of control completed as of January 27, 2026 (the "*Pro Forma* Transfer"). The *Pro Forma* Transfer did not result in a change of the controlling party of either entity and has no impact on their day-to-day operations. This amended Attachment supplements the original filing, which was submitted on February 24, 2026 and designated Filed No. ITC-T/C-20260218-00047.

ACN provides interstate and international telecommunications services, including resold long distance wireline and resold Commercial Mobile Radio Services. ACN provides domestic services by virtue of blanket 214 authority pursuant to 47 C.F.R. § 63.01. ACN is a wholly-owned subsidiary of LKN. While LKN itself does not provide telecommunications services, it holds the international 214 license under which ACN is authorized to provide international service, ITC-214-20000203-00052.¹

LKN is a wholly owned subsidiary of LKN Global Holdings, Inc. ("LKNGH"), which was ultimately owned by five individual shareholders (through trusts and other corporate entities) prior to the *Pro Forma* Transfer. Following the *Pro Forma* Transfer, LKNGH is 90% owned by Blue Phoenix Holdings LLC, which is owned (through trusts) by two of the shareholders who held more than 50% of the equity and voting interest in LKNGH prior to the *Pro Forma* Transfer. As a result, the ultimate controlling equity and voting interest in LKN and its wholly-owned subsidiary, ACN, has not changed.

LKN is an international 214 licensee pursuant to authorization under File No. ITC-214-20000203-00052, which authorizes the provision of global or limited global facilities-based and resale service. LKN does not provide international telecommunications services directly.

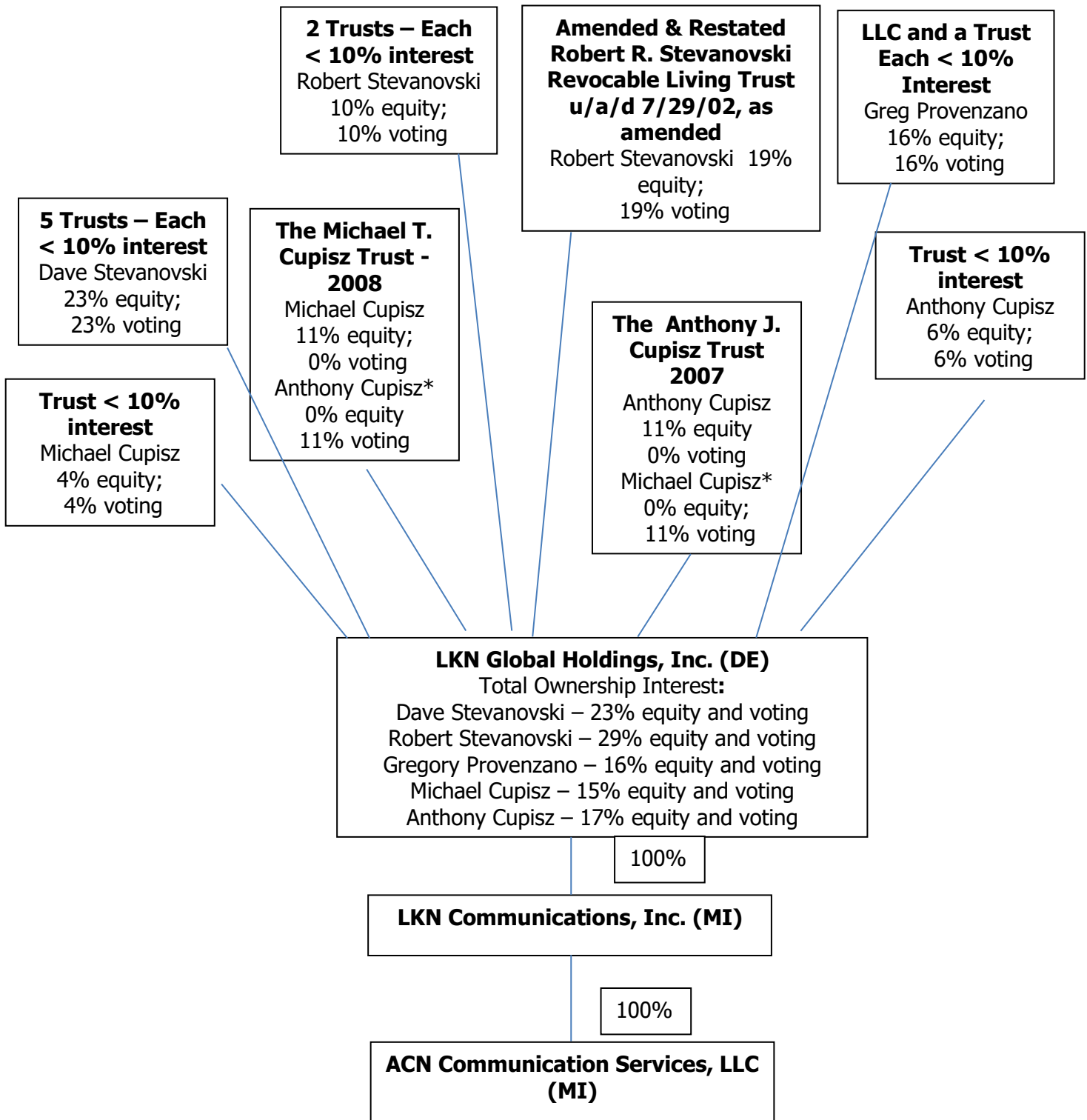

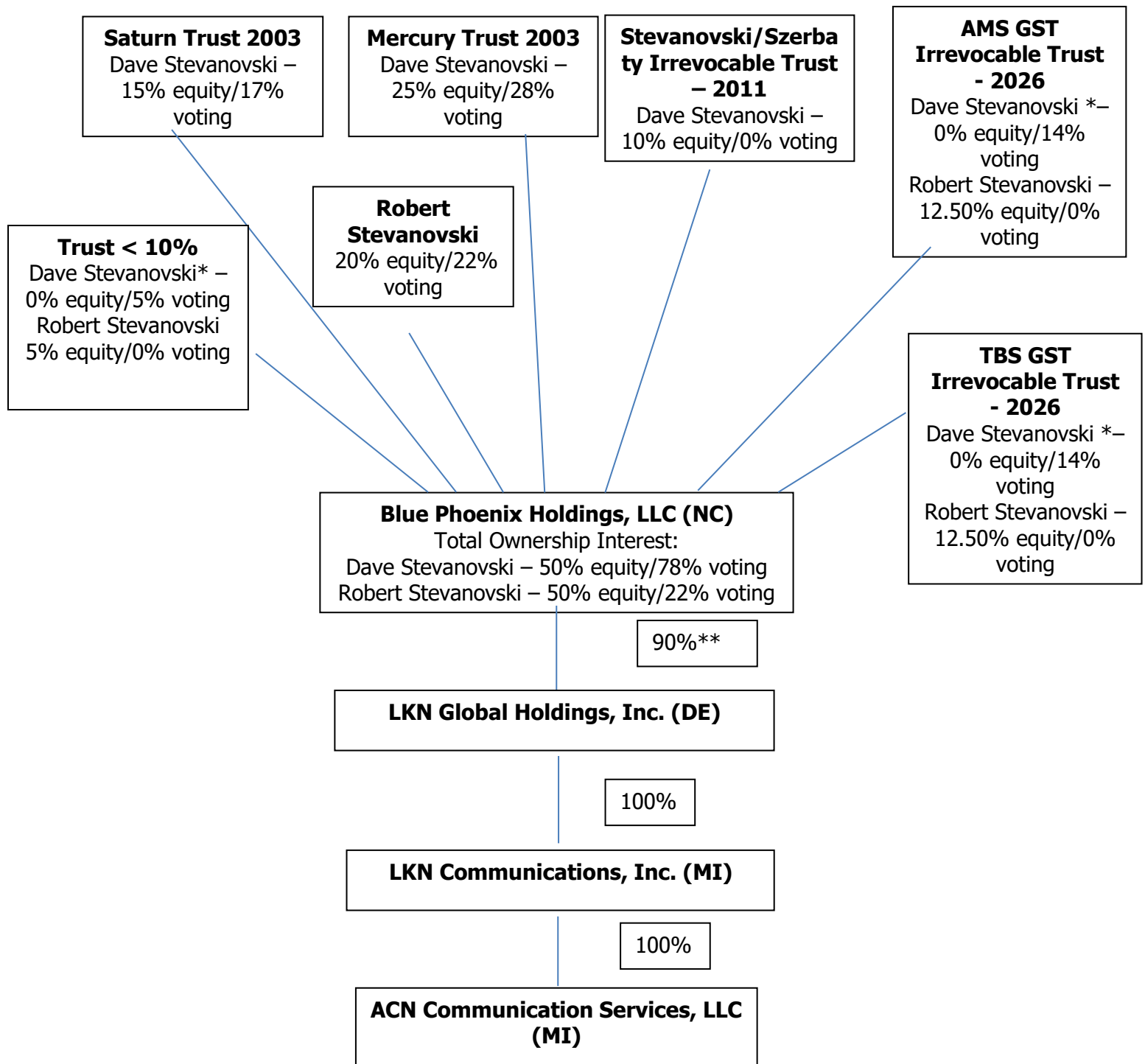
Corporate Ownership Structure
