Foreign Carrier and Destination Countries (47 C.F.R. § 63.18(j))

Applicant certifies that it requests authority to provide international telecommunications services to all of the destination markets identified above in which it is affiliated with a telecommunications carrier. Applicant certifies pursuant to 47 C.F.R. § 63.18(j)(3) that it seeks authority to provide these services in countries in which the entity that controls Applicant also controls the above-listed foreign carriers in their respective countries.

WTO Membership of Destination Countries (47 C.F.R. § 63.18(k))

In accordance with Section 63.18(k)(1) of the Commission's rules, Applicant certifies that all of the countries listed above are WTO Member countries, with the exception of Azerbaijan, Bhutan, Faroe Islands, Kosovo, Somalia, and Sudan.

The non-WTO foreign affiliates in Azerbaijan, Bhutan, Faroe Islands, Kosovo, Somalia, and Sudan lack 50 percent market share in international transport facilities or services on the foreign end of their particular routes. Therefore, these affiliates do not have market power in their particular foreign countries, and Applicant qualifies for a presumption of non-dominance under Section 63.10(a)(3) of the Commission's rules, as further described below.

Non-Dominant Regulatory Classification (47 C.F.R. § 63.18(m))

Applicant seeks non-dominant classification on all routes in which it is affiliated with a foreign carrier. Applicant qualifies for a presumption of non-dominance under Section 63.10(a)(3) of the Commission's rules because the affiliates in these countries have no market power on the foreign end of any of these routes. All of Applicant's foreign carrier affiliates have market shares under 50 percent in the international transport and local access markets on the foreign end of U.S. routes to these countries. None of these entities are listed on the Commission's List of Foreign Telecommunications Carriers that Are Presumed to Possess Market Power in Foreign Telecommunications Markets.³

Foreign Ownership Review (47 C.F.R. § 63.18(p))

Not applicable. Applicant does not have any owner that holds a ten percent or greater direct or indirect equity or voting interest, or a controlling interest, and that is not a U.S. citizen.

Request for Streamlined Treatment (47 C.F.R. § 63.12)

This Application qualifies for streamlined treatment under section 63.12 of the Commission's rules because (i) Applicant is not affiliated with a dominant foreign carrier; (ii) Applicant qualifies for a presumption of non-dominance under Section 63.10(a)(3) of the Commission's rules because its affiliates in foreign countries have no market power on the foreign end of any of their U.S. routes to these countries; and (iii) none of the other scenarios outlined in Section 63.12(c) of the Commission's rules apply.
