Dear Secretary Dortch:

Pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act") and Section 63.24(f)(2) of the Commission's rules, Birch Telecom of Missouri, Inc. ("Birch Missouri") (FRN# 0003732294), by its undersigned counsel, hereby notifies the Commission of a *pro forma* assignment and transfer of control of Section 214 authority formerly held by Birch Missouri to Birch Telecom of Missouri, Debtor-in-Possession ("Birch Missouri DIP") (FRN# 0008125056). The following assignment and transfer of control took place on July 29, 2002 and resulted from Birch Missouri and its parent company, Birch Telecom Inc. ("Birch") commencing a chapter 11 case under the Federal Bankruptcy Code:

- 1. Birch Missouri assigned its authority to provide international services on a resale basis between the United States and points foreign (File No. ITC-214-19990701-00441) to Birch Missouri DIP; and
- 2. Birch transferred control of Birch Missouri DIP to Birch Telecom, Inc., Debtor-in-Possession ("Birch DIP").

On June 29, 2002, upon the filing of its bankruptcy case in the U.S. Bankruptcy Court for the District of Delaware, the aforementioned assignment and transfers of control occurred. In connection with its bankruptcy filing, Birch DIP proposed a prepackaged chapter 11 plan of reorganization (the "Reorganization Plan"), for which Birch has solicited and received

sufficient votes to enable the Reorganization Plan to be confirmed by the U.S. Bankruptcy Court.<sup>1</sup>

Birch Oklahoma also herby respectfully requests an extension of time to file this notification, retroactive to August 28, 2002, the date 30 days after assignment and transfer of control on which this notice was otherwise due. Although the Commission was timely notified of the *pro forma* assignments and transfers or control of Birch and Birch's subsidiaries domestic Section 214 authorizations, through an attorney oversight, Birch and Birch Missouri neglected to notify the Commission of the effect of this bankruptcy on Birch's international Section 214 authorizations. In the process of coordinating the necessary bankruptcy filings, transaction documents, and recapitalization processes, counsel for the Birch and Birch Missouri inadvertently overlooked Birch's international Section 214 licenses, and now seek to remedy that omission. Birch and Birch Missouri apologize for this oversight and any inconvenience it may cause, and can assure the Commission that they have taken steps to prevent a repeat of this occurrence.

A certification that the assignment and transfer of control were *pro forma* and that, together with all previous *pro forma* transactions, did not result in a change in the actual controlling party is attached hereto as <u>Exhibit A</u>.
