Dear Ms. Dortch:

Pursuant to 47 U.S.C. § 214 and 47 C.F.R. § 63.24, on **January 23, 2003**, Mpower Communications Corp. ("Mpower") and LDMI Telecommunications, Inc. ("LDMI") filed two separate applications with the Commission. One application requested authority to transfer from Mpower to LDMI assets in **Michigan** that can be used for the provision of international services. One application requested authority to transfer from Mpower to LDMI assets in **Ohio** that can be used for the provision of international services.

For each separate application, LDMI submits this notice to clarify indirect ownership interests in LDMI in accordance with 47 C.F.R. § 63.18(h).

As identified in each of the January 23, 2003 applications, PNC Capital Corp. owns 15.0% of LDMI.

In addition, however, PNC Capital Corp. is wholly owned by PNC Holding, L.L.C. PNC Holding, L.L.C. is located at 249 Fifth Avenue, Pittsburgh, PA 15222. PNC Holding, L.L.C. is a holding company that owns an equity investment firm.

PNC Holding, L.L.C. is wholly owned by PNC Financial Services Group, Inc., a publicly traded corporation. PNC Financial Services Group, Inc. also is located at 249 Fifth Avenue, Pittsburgh, PA 15222. PNC Financial Services Group, Inc.'s principal business is the provision of financial services. No one owns more than 10% of PNC Financial Services Group, Inc.

Please note that on January 24, 2003, Mpower and LDMI also filed with the Commission two separate applications related to the transfer of domestic assets in Michigan and Ohio. A notice regarding those applications is being separately filed with the Wireline Competition Bureau.
