Dear Ms. Dortch:

Effective immediately, Covad Communications Company ("CCC"), DSLnet Communications, LLC ("DSLnet"), and DSLnet Communications VA, Inc. ("DSLnet-VA") hereby surrender their international 214 authorizations, and blanket domestic 214 authorizations. The international 214 authorizations to be relinquished are:

- CCC: File No. ITC-214-20021118-00544.
- <u>DSLnet</u>: File Nos. ITC-214-19990716-00434 and ITC-ASG-20030611-00290. ¹

Pursuant to a series of *pro forma* intra-corporate mergers with their affiliate DIECA Communications, Inc. (for which the companies separately provided notice to the Commission), CCC, DSLnet and DSLnet-VA no longer exist as separate entities, nor do they provide interstate domestic or international telecommunications services, and therefore, they no longer require their 214 authorizations. Because the companies do not currently provide such services, they respectfully submit that the surrender of their 214 authorizations is reasonable and necessary and will not harm the present or future public interest, convenience and necessity. The operations of these companies have been taken over by DIECA, which is not discontinuing any domestic or international services at this time.
