Dear Ms. Dortch:

On behalf of Vanco Direct USA, LLC ("Vanco"), this letter notifies the Commission that on August 1, 2005, Vanco and Universal Access, Inc., Debtor-in-Possession ("UAI-DIP") completed the transaction described in the above-referenced Applications. Due to an oversight, this Notice of Consummation was not filed within 30 days of closing and Vanco requests that the Commission accept this as a late-filed notice.

Vanco notes that the International 214 Authorization of UAI-DIP (ITC-214-19990811-00546) (the "UAI 214") was not included in the assets assigned to Vanco. Neither Vanco nor this firm have any continuing relationship with UAI-DIP and are unaware of the ongoing status of UAI-DIP, if any. Vanco is therefore not in a position to surrender or to direct the Commission to cancel the UAI 214 as described in the Commission's Public Notice dated August 4, 2008 (DA No. 05-2254).
