On November 28, 2006, NewComm filed for reorganization under Chapter 11 of the U.S. Bankruptcy Code, 11 U.S.C. §§ 101, *et seq.*, with the United States Bankruptcy Court for the District of Puerto Rico, Case No. 06-04755 (ESL). On November 28, 2006, NewComm made required filings to assign over 100 authorizations in two different radio services to NewComm DIP. NewComm certifies that this assignment was *pro forma* and that this assignment does not result in a change in the actual controlling party.
