
Dear Ms. Dortch:

In accordance with 47 C.F.R. § 1.65, the purpose of this letter is to report that there are no longer any entities that own 10 percent or more of the equity of FairPoint Communications, Inc. ("FairPoint"), the transferee in the above-referenced matter. Although FairPoint had identified two such entities in its applications relating to certain domestic and international Section 214 authorizations — Thomas H. Lee Equity Fund IV, L.P., and Wellington Management Company, L.L.P. — both of these firms have since sold all or portions of their interests such that they now fall below the Commission's 10-percent threshold. Moreover, FairPoint is unaware of any other entity with an ownership interest in FairPoint that now exceeds that threshold.
