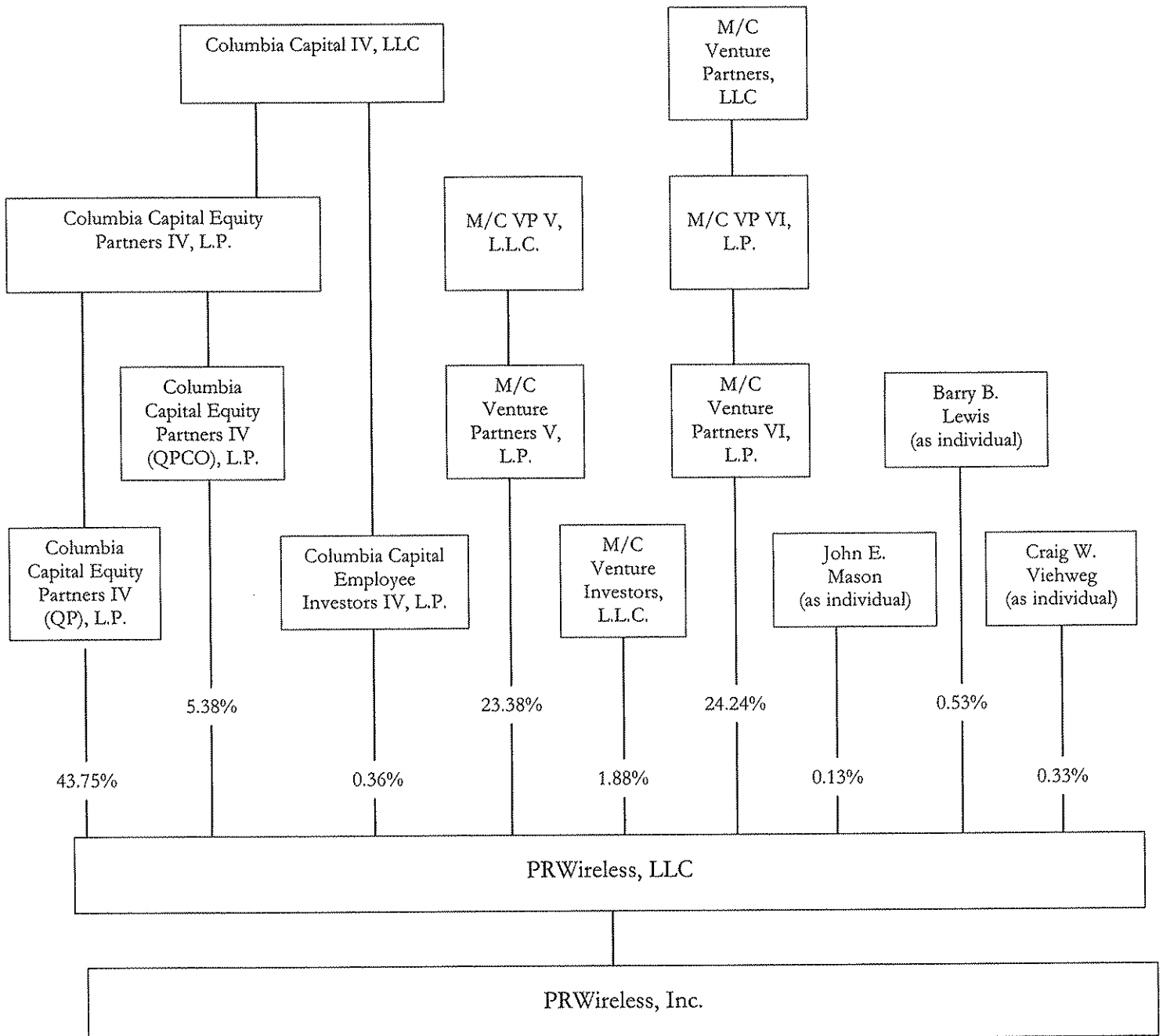

The Columbia Capital entities are affiliated investment funds, some of which individually hold a greater than 10% ownership interest in PRWireless, Inc. (and therefore must be reported on Schedule A to the Form 602) and some of which do not (and therefore do not need to be reported on Schedule A to the Form 602). Based upon the FCC's multiplier rule,² the percentage interests reported for Columbia Capital IV, LLC and Columbia Capital Equity Partners IV, L.P. is the aggregate interest held by all of the affiliated entities they control, including those that do not hold greater than 10% individually. The chart above reflects the relationship among these affiliated investment funds and their respective ownership interests in PRWireless, Inc., regardless of percentage, and is described in more detail as follows:

- a. Columbia Capital IV, LLC is the general partner of Columbia Capital Equity Partners IV, L.P., which in turn is the general partner of Columbia Capital Equity Partners IV (QP), L.P., which holds a direct interest of 43.75% in PRWireless, LLC, which owns 100% of PRWireless, Inc.;
- b. Columbia Capital Equity Partners IV, L.P. also is the general partner of Columbia Capital Equity Partners IV (QPCO), L.P., which holds a direct interest of 5.38% in PRWireless, LLC, which owns 100% of PRWireless, Inc.; and
- c. Columbia Capital IV, LLC also is the general partner of Columbia Capital Employee Investors IV, L.P., which holds a direct interest of 0.36% in PRWireless, LLC, which owns 100% of PRWireless, Inc.

In the aggregate, the affiliated Columbia Capital entities hold an indirect 49.50% interest in PRWireless, Inc.

The M/C Venture entities are affiliated investment funds, some of which individually hold a greater than 10% ownership interest in PRWireless, Inc. (and therefore must be reported on Schedule A to the Form 602) and some of which do not (and therefore do not need to be reported on Schedule A to the Form 602). The chart above reflects the relationship among these affiliated investment funds and their respective ownership interests in PRWireless, Inc., regardless of percentage. Based upon the FCC's multiplier rule,³ M/C Venture Partners V, L.P. and its general partner, M/C VP V, L.L.C., each hold an indirect interest of 23.38% in PRWireless, Inc., and are included in Schedule A accordingly. Likewise, M/C Venture Partners VI, L.P., its general partner, M/C VP VI, L.P., and its general partner, M/C Venture Partners, LLC, each hold an indirect interest of 24.24% in PRWireless, Inc. and are listed in Schedule A accordingly. M/C Venture Investors, L.L.C., however, holds an indirect interest of 1.88% in PRWireless, Inc., so that no Schedule A is required. In the aggregate, the affiliated M/C Venture entities hold an indirect 49.50% interest in PRWireless, Inc.
