Dear Ms. Dortch:

On behalf of Bandwidth.com CLEC, LLC (“Bandwidth”) and Computer Network Technology Corporation (“CNT”) (together, the “Applicants”), this letter responds to certain inquiries from staff of the International and Wireline Competition Bureaus.

First, Applicants clarify that they do not currently have any affiliates that provide regulated telecommunications services except for those entities listed in the Application (Bandwidth.com, Inc. and CNT Telecom Services, Inc.).

Second, Applicants clarify that customers of CNT have not yet been formally notified that Bandwidth will become their new data service provider. All of the services provided to the CNT customers being transferred are data services, provided under individually

negotiated contracts. Applicants intend to provide customers notice pursuant to the requirements of their individual contracts, but do not intend to file a copy of the notice in Docket No. 00-257 because none of the services provided by CNT are presubscribed or voice service. Because the proposed transaction will not result in any change to a subscriber's presubscribed carrier, the rules regarding changes in presubscribed carriers, 47 C.F.R. 64.1100 *et seq.*, do not apply to the proposed transaction

Third, Applicants clarify that the Agreement (as defined in the Application) is dated as of November 8, 2007.

Finally, Bandwidth clarifies that neither Mr. David Morken nor Mr. Henry Kaestner has de facto or de jure control over Bandwidth.com, Inc.
