AT&T Inc. and certain of its subsidiaries ("AT&T") and Celco Partnership d/b/a Verizon Wireless and certain of its subsidiaries ("Verizon Wireless") have filed a series of applications pursuant to Sections 214 and 310(d) of the Communications Act of 1934, as amended. In these applications, AT&T and Verizon Wireless (the "Applicants") seek Commission approval of an exchange of certain wireless licenses, spectrum manager leasing arrangements, and related authorizations in parts of Arizona, Kentucky, Nevada, New York, Ohio, Pennsylvania, Vermont, and Washington. In addition, Verizon Wireless requests a declaratory ruling extending its current Section 310(b)(4) authority to hold interests in common carrier licenses and authorizations to encompass DC Kentucky Newco, DC Other Newco, and the FCC licenses that they will hold following transfer to Verizon Wireless as a result of this transaction.
