

**APPLICATION FOR TRANSFER AND ASSIGNMENT OF INTERNATIONAL SECTION 214
AUTHORIZATION**

Mon-Cre Wireless, Inc. d/b/a Mon-Cre Long Distance (“Mon-Cre Wireless”) and Mon-Cre Telephone Cooperative, Inc. (“Mon-Cre Coop”) hereby seek authorization pursuant to Section 214(a) of the Communications Act of 1934, as amended (the “Act”), 47 U.S.C. § 214, and Section 63.18(e)(3) of the Federal Communications Commission’s (“FCC” or the “Commission”) Rules, 47 C.F.R. § 63.18(e)(3), for the transfer and assignment of Mon-Cre Wireless’ existing Section 214 authorization to provide international telecommunications services to its Alabama customers to Mon-Cre Coop, pursuant to the liquidation and transfer of assets of Mon-Cre Wireless to Mon-Cre Coop. Mon-Cre Wireless is a wholly-owned subsidiary of Mon-Cre Coop, and following the transfer and liquidation, Mon-Cre Wireless will cease to exist, and Mon-Cre Coop will become the operating telecommunications service provider for international toll resale services to all Mon-Cre Wireless customers.

Simultaneous with the filing of this application, Mon-Cre Wireless and Mon-Cre Coop have filed a separate joint application with the FCC for the transfer and assignment of mon-Cre Wireless’ domestic Section 214 authority to Mon-Cre Coop. Pursuant to a joint notice of *pro forma* transfer filed with this Commission, Mon-Cre Wireless and Mon-Cre Coop have also

provided notice of the transfer of Mon-Cre Wireless' subscriber bases for the provisioning of interLATA and limited intrastate telephone toll resale services, international toll, and Internet services, to Mon-Cre Coop¹.

Under 47 C.F.R. § 63.18 (e)(3), applicants seeking to transfer control of a common carrier holding international Section 214 authorization or to acquire, by assignment, another carrier's existing international Section 214 authorization must comply with Section 63.18(e)(3) of the Commission's Rules. In accordance therewith, Mon-Cre Wireless and Mon-Cre Coop provide the following information to this Commission:

- (d) A statement regarding previous authority under Section 214 and a general description of the facilities and services authorized:

Mon-Cre Wireless has existing authority under Section 214 to provide resold international toll services.

- (e) No other entity directly or indirectly owns at least ten percent (10%) of the equity of Mon-Cre Telephone Cooperative, Inc., which, as a cooperative, is wholly owned by its subscribers. Mon-Cre Wireless is, in turn, a 100% wholly-owned subsidiary of Mon-Cre Telephone Cooperative, Inc.

- (f) Mon-Cre Coop hereby certifies that it is not, and is not affiliated with, a foreign carrier.


- (g) Mon-Cre Coop hereby certifies that it does not seek to provide international telecommunications services to any destination country for which it is a foreign carrier, controls a foreign carrier or for which any entity having more than 25% ownership in or control of Mon-Cre Coop controls a foreign carrier in that country. Neither do any foreign carriers own in the aggregate more than 25% of Mon-Cre Coop and are parties to or the beneficiaries of a contractual relation affecting the provision or marketing of international basic telecommunications services in the United States.

- (h) Mon-Cre Coop hereby certifies that it has not agreed to accept special concessions directly or indirectly from any foreign carrier with respect to any international route where the foreign carrier possesses market power on the foreign end of the route and will not enter into such agreements in the future.

- (i) Mon-Cre Wireless and Mon-Cre Coop hereby certify that no party to the application is subject to a denial of Federal benefits pursuant to Section 5301 of the Anti-Drug Abuse Act of 1988, 21 U.S.C. § 853a.
- (j) Mon-Cre Coop hereby certifies that it will comply with the terms and conditions contained in §§ 63.21, 63.22 and/or 63.23 of the Commission's Rules, as appropriate.
- (k) Mon-Cre Wireless and Mon-Cre Coop hereby state that their application meets the requirements for streamlined processing under Section 63.12 of the Commission's Rules, 47 C.F.R. § 63.12, and hereby seek streamlined processing of this application. Mon-Cre Coop and Mon-Cre Wireless understand that this application may be granted by the Commission thirty-five (35) days after the date of public notice listing the application as accepted for filing. Mon-Cre Coop further understands that it has a duty to notify the Commission of consummation of the assignment or transfer or decision not to proceed within thirty (30) days thereof.




