
SUPPLEMENT TO APPLICATION

On December 31, 2009, Global Capacity Group, Inc. (“GCG”), its affiliate, Global Capacity Direct, LLC f/k/a Vanco Direct USA, LLC (“Vanco”), and Global Telecom & Technology Americas, Inc. (“GTT Americas” and together with GCG and Vanco, “Applicants”) filed an application requesting authority to assign certain customer contracts and associated account information from GCG and Vanco to GTT Americas (the “Application”). The Commission assigned the Application the above-referenced docket number. Pursuant to Staff request, the Applicants hereby clarify and supplement their Application with the following:

The Applicants clarify that the customers to be assigned from GCG and Vanco to GTT Americas are customers located not in any specific state or region, but rather, the customers are located throughout the service territories of GCG and Vanco. The customers to be assigned to GTT Americas are interstate data private line customers only, not the entire customer bases of GCG and Vanco. GCG and Vanco will continue to provide service to their other customers pursuant to their existing telecommunications authorizations post-close.

The Applicants respectfully submit that the public interest, convenience, and necessity would be furthered by grant of this Application.
