5) Description of Transaction

By this application, the FCC is being notified of the *pro forma* assignment of the Section 214 authorization (File No. ITC-214-19981216-00896) held by SEI Data, Inc. to its parent company Southeastern Indiana Rural Telephone Co-op, Inc. (“Southeastern”). The *pro forma* assignment occurred on November 9, 2009. SEI Data is a wholly-owned subsidiary of Southeastern. Accordingly, *pro forma* treatment of the assignment is appropriate pursuant to Section 63.24(d) of the Commission’s rules.

Southeastern is a member-owned cooperative corporation whereby no shareholder or other equity holder has a ten percent or greater direct or indirect interest in Southeastern stock. Southeastern provides telecommunications services, including local and long distance telephone service, as an incumbent local exchange carrier (ILEC) serving several rural counties in Southeastern Indiana. SEI Data provides similar services as a competitive local exchange carrier, as well as wireless broadband services. Southeastern itself held no Section 214 authorizations prior to the *pro forma* assignment.

SEI Data will continue to provide international telecommunications service under the Section 214 authorization now held by Southeastern following the *pro forma* assignment. Accordingly, to the extent necessary, this letter also provides notification pursuant to Section 63.21(h) of the Commission’s rules.
