On June 2, 2010, Inmarsat Hawaii, Inc. (“Inmarsat Hawaii”) assigned its international Section 214 authority to ISAT US. As Inmarsat Hawaii and ISAT US have the same parent, Inmarsat U.S. Holdings Inc., this assignment was *pro forma* in nature and did not require prior approval from the Commission. No other change in ownership or control was effected as a result of this assignment.
