As part of the above-captioned application, One Communications Corp. ("One"); FiberNet of Virginia, Inc., FiberNet, L.L.C., FiberNet Telecommunications of Pennsylvania, LLC, and FiberNet of Ohio, LLC (collectively "FiberNet") and NTELOS Inc. (together, with One and FiberNet, the "Applicants") request a waiver of the cable/telco buyout restrictions in Section 652(b), 47 U.S.C. § 572(b), pursuant to Section 652(d)(6) of the Act, 47 U.S.C.

§ 572(d)(6), and Section 76.505(d)(6) of the Commission's Rules, 47 CFR § 76.505(d)(6) ("Section 652(d)"). In connection with this request, Applicants have agreed to notify affected local franchising authorities ("LFA"s) of the proposed transaction, ensuring that each LFA is afforded its opportunity to approve or disapprove. Pursuant to discussions with Staff in the Wireline Competition Bureau, Applicants submit a list of the LFAs located in all service areas where FiberNet and Suddenlink operations overlap, and certify that, to the best of their belief, the list is accurate and complete.

Applicants' Minimum Service List

1. Identifying the Relevant Service Areas

For purposes of the requested waiver, notice must be served upon the LFA for each "overlap" service area; *i.e.*, where Cequel Communications, LLC d/b/a Suddenlink ("Suddenlink")¹ and FiberNet both operate. Initially, the Suddenlink service areas were identified based upon information posted on the Suddenlink website. Material provided by the West Virginia Public Service Commission ("WV PSC") confirmed the Suddenlink service areas in that state. The Commission's Cable Operations and Licensing System (COALS) database was culled for additional Suddenlink listings.² Then, the cumulative list of Suddenlink service areas was compared with FiberNet's operating areas and the resulting overlap service areas identified. These are located in West Virginia, Kentucky, Maryland, Ohio and Virginia. A list of the cities

We identified four townships and one county in Ohio as service areas that had not previously been identified from the Suddenlink website list.

from which FiberNet's network is used to provide originating services is attached hereto for informational purposes.

2. Identifying the LFAs³

The WV PSC, which regulates cable providers, provided Applicants with a list of Suddenlink LFAs in that state. WV PSC staff pointed us to directories from the West Virginia Municipal League and the West Virginia Association of Counties to obtain addresses and contact information for each LFA. No specific "local franchise authority" is listed in these directories, however, so Applicants propose, at a minimum, to serve the clerk or highest administrative office-holder (*e.g.*, mayor, city manager, county executive) in each location.⁴

For the other states, each overlapping service area was researched to identify the associated governing body or municipal authority.⁵ Certain of the identified service areas are

In compiling an LFA service list, Applicants confirmed that the following agencies, organizations and individuals do <u>not</u> have this information compiled in any usable form: FCC Media Bureau (the COALs database does not identify franchise requirements and does not identify the LFAs); the state utility commissions in Kentucky, Maryland, Ohio, and Virginia; the National Association of Telecommunications Officers and Advisors (NATOA); Television & Cable Factbook (online version); state cable TV associations for Kentucky, Maryland, Ohio, Virginia and West Virginia; municipal leagues or equivalents in Kentucky, Maryland, Ohio, Virginia and West Virginia; associations of counties in Kentucky, Maryland, Ohio, Virginia and West Virginia.

This approach is consistent with the way that the parties created the service list in the CIMCO case. See Applications Filed For the Acquisition of Certain Assets of CIMCO Communications, Inc. by Comcast Phone LLC, Comcast Phone of Michigan, LLC and Comcast Business Communications, LLC, Memorandum Opinion and Order and Order on Reconsiderations, WC Docket No. 09-183, FCC 10-41, rel. Mar. 15, 2010, at ¶ 15. The specific recipient varies by category of governing body. In West Virginia municipalities, Applicants will serve both the Mayor and the Clerk while in the counties, the notice will be served upon the County Commissioners.

Applicants utilized municipal directories, Secretary of State inquiries, general Internet research and targeted phone calls to area governing bodies to establish contact

unincorporated areas that have no local government of their own. In these cases, Applicants identified the county in which the unincorporated area is located and included the county officials in the service list. Generally, Applicants looked at municipal league and county association directories for contact information. Each city, town and county government was contacted to confirm issuance of a franchise to Suddenlink⁶, identify the appropriate recipient for a legal notice and inquire regarding jurisdictions which might have concurrent authority to issue cable franchises for the specific community. Most communities directed that notices be sent to the community clerk or highest official. No community identified a "franchise department" or similar agency. In Ohio, personnel in several municipal offices noted that local townships also may have local franchise authority.

In light of what was learned from talking with community officials, Applicants decided to assume conservatively that all of the governing bodies contacted have local franchise authority over Suddenlink. Thus, the proposed service list contains all of the cities and towns that were researched, as well as the counties in which those cities and towns are located. For Ohio LFAs, Applicants further included all the townships in which overlapping service areas are

information for the relevant municipalities. These municipal entities were then contacted for confirmation.

It was not always possible to obtain clear confirmation of issuance of a franchise. As noted herein, in order to ensure adequate notification, Applicants decided to err on the side of over-inclusion and notify all of the contacted communities, whether they acknowledged a Suddenlink franchise or not.

located. Consistent with the method proposed for West Virginia, notifications to authorities in the other states will be addressed to the municipal clerk or highest official.⁷

3. Notifying the LFAs

The Applicants propose to serve notice of the transaction on each party included in the attached list, and believe that delivery of such notices satisfies the requirements of Section 652(d) and applicable Commission precedent. However, in the interest of making sure that no LFAs are inadvertently omitted from the notice process, the Applicants intend to take one additional step. Specifically, the vast majority of FiberNet's operations are conducted in West Virginia. Even where Suddenlink's service territory does not overlap with FiberNet's service territory, the Applicants intend to serve notice of the transaction upon the chief administrative officer of each locality in West Virginia where Suddenlink provides service. The Applicants will utilize the list of Suddenlink LFAs obtained from the WV PSC, and the directory contact information received from the West Virginia Municipal League and West Virginia Association of Counties, for that purpose. Accordingly, notice actually will be provided to *substantially more* LFAs than are required by statute.

Specific recipients will vary based upon the category of governing body and feedback from discussions with local officials. In municipalities, both the Mayor and the Clerk may be served. For Ohio counties, the County Commissioners will be served, and so forth. In all cases, Applicants have opted to over-serve governing bodies to ensure adequate notification.

Conclusion and Certification

Applicants' required service list for notification to affected LFAs, consistent with Section 652(d), is appended as *Attachment 1*. Applicants propose to serve a copy of the Commission's *Public Notice* on each listed LFA contact via overnight delivery (USPS Express Mail).⁸ As explained above, Applicants will send notice to the chief administrative officers of other West Virginia localities where Suddenlink provides service in the same manner. An accompanying cover letter will explain the context of the notice and provide contact information for Applicants' attorneys should any of the municipal officials have questions. Accompanying the service list is a certification from Applicants, attesting that, to the best of their belief, *Attachment 1* represents an accurate list of the LFAs which must be notified in connection with the requested waiver, to satisfy the requirements of Section 652(d). Finally, appended as *Attachment 2*, Applicants submit a list of FiberNet's collocation sites, reflecting the Company's facilities coverage and effective service areas.
