### **Answers to Questions 10 and 11**

On December 31, 2010, a *pro forma* transfer of control of Smithville Telecom, LLC from Earles Family, LLC (FRN: 0015572977) to Earles Family, Inc. (FRN: 0020587085) took place. Both the Earles Family, LLC and the Earles Family, Inc. were, in turn, controlled by the Darby A. McCarty Revocable Trust (Darby A. McCarty, Trustee), which owned 100 percent of the voting stock of each.

At the time of the December 31, 2010 transaction, it was believed that Smithville Telecom, LLC was the holder of the subject International Section 214 Authorization for Global Resale. However, while preparing the present notification, it was discovered that such International Section 214 Authorization (File No. ITC-214-19991124-00716) was still held in the name of Smithville Telecom, Inc., which had been converted into Smithville Telecom, LLC via a *pro forma* transaction several years previously. It took a few weeks to find the old FRN password for Smithville Telecom, Inc. necessary to access the International Bureau's online application system.

This notification does not fit within the parameters of the normal *pro forma* notification. It was filed as a notification of *pro forma* assignment to reflect the prior change of the authorization holder from Smithville Telecom, Inc. to Smithville Telecom, LLC, as well as the *pro forma* transfer of the intermediate owner from the Earles Family, LLC to the Earles Family, Inc. that triggered it.

Throughout the entire period in which these transactions took place, Ms. Darby A. McCarty, as the President of both Smithville Telecom, Inc. and Smithville Telecom, LLC, and as the sole trustee and sole beneficiary of the Darby A. McCarty Revocable Trust that has owned 100 percent of the voting stock of both the Earles Family, LLC and the Earles Family, Inc., has controlled the subject International Section 214 Authorization.
