Answers to Questions 11 and 13

On June 23, 2011, Hawaii Pacific Teleport, L.P. (“HPT”) filed a voluntary petition for bankruptcy under Chapter 11 of the U.S. Bankruptcy Code with the U.S. Bankruptcy Court for the District of Hawaii. As a result of this Chapter 11 filing, HPT is operating as Hawaii Pacific Teleport, L.P., Debtor-in-Possession (“HPT DIP”), under the supervision of the Bankruptcy Court. During the Chapter 11 proceeding, the ownership structure of HPT DIP will remain the same.

HPT is a Hawaii limited partnership. Its partnership interests as of 8/2/11 are held as follows:

Hawaiian Transmission Solutions, LLC, General Partner	1%	100% of the voting rights in HTS are held by 1050 Piiholo LLC, whose sole Member is Neil Struminger. 100% of the equity interest is held by Inverse Asia, Inc. The sole Manager is Hawaii Capital Holdings, LLC, whose sole Member is Leeana Smith-Ryland.
Inverse Asia, Inc., Limited Partner	63%	Alan Crutchfield has a 51% ownership interest and 1050 Piiholo LLC has a 46% ownership interest.
Christopher Guthrie, Limited Partner	36%	Individual.
