**Question 9** 

This application serves to notify the Commission of a two-step *pro forma* transaction that

occurred on December 31, 2011, in which Controladora de Servicios de Telecomunicaciones,

S.A. de C.V. ("Consertel") assigned its two international Section 214 authorizations (File Nos.

ITC-214-20000519-00306 and ITC-214-19980813-00564) to Latam Telecommunications,

L.L.C. ("Latam"), and control of Latam was transferred from Consertel to Sercotel, S.A. de C.V.

("Sercotel"). The *pro forma* transfer of control of Latam occurred immediately after the

consummation of the assignment from Consertel to Latam.

The assignment and transfer of control are *pro forma* in nature. Prior to the transaction,

Latam was a wholly owned subsidiary of Latam Holdings Inc., which in turn, was wholly owned

by Consertel. Moreover, Consertel, as transferor of Latam, and Sercotel, as transferee, each are

commonly controlled by América Móvil, S.A.B. de C.V. ("América Móvil"). Therefore,

ultimate control of the entity holding the authorizations at issue has not changed.

> information, Carlos Slim Helú and certain members of his family hold directly and indirectly 42.43% of the equity and 65.52% of the voting stock in América Móvil.<sup>5</sup> Other Mexican and foreign investors hold the remaining equity and voting stock of América Móvil.<sup>6</sup> No public investor holds more than 10% of América Móvil's capital stock.

América Móvil owns directly 99.99% of Sercotel. The remaining 0.01% is held by Amov IV, S.A. de C.V., a wholly owned subsidiary of América Móvil.

<sup>5</sup> 21.93% of the equity (approximately 45.04% of the voting stock) of América Móvil is owned directly and indirectly, including beneficially owned, through a trust for the benefit of Carlos Slim Helú and certain members of his family, all of whom are Mexican citizens. Inmobiliaria Carso, S.A. de C.V. (a non-public holding company wholly owned by the Slim family and duly organized under Mexican laws) also owns shares of América Móvil that represent less than ten percent of the voting shares of América Móvil. In addition, Carlos Slim Helú and members of his family individually own shares of América Móvil, though none in his or her individual capacity owns ten percent or more of the voting shares of América Móvil.

AT&T Inc. ("AT&T") (formerly known as SBC International, Inc.), a widely and publicly held corporation incorporated under the laws of the state of Delaware, holds approximately 9.11% of the equity (approximately 24.5% of the voting stock) of América Móvil through AA shares. Based on beneficial ownership reports filed with the U.S. Securities and Exchange Commission ("SEC") on March 1, 2011, AT&T also owned approximately 752 million L shares. As of April 30, 2011, 38.7% of the outstanding L shares of América Móvil were represented by L Share ADSs, each representing the right to receive 20 L shares, and 99.3% of the L Share ADSs were held by registered holders with addresses in the United States. 33.7% of the A shares were held in the form of A Share ADSs, each representing the right to receive 20 A shares, and 99.5% of the A Share ADSs were held by registered holders with addresses in the United States.

## **Question 13**

Latam, a Delaware limited liability company, was formed in 2010 as a direct subsidiary of Latam Holdings Inc., which is a direct subsidiary of Consertel. Consertel is a majority-owned, direct subsidiary of Telmex Internacional, S.A.B. de C.V. ("Telint"), and Telint, in turn, is majority-owned and controlled by Carso Global Telecom, S.A.B. de C.V. ("CGT"). América Móvil owns directly and indirectly 99.9% of CGT and 97.4% of Telint and, as a result, controlled Consertel and Latam prior to the transaction. On December 31, 2011, Consertel assigned its two international Section 214 authorizations (File Nos. ITC-214-20000519-00306

Telint holds 99.99999991% of the capital stock of Consertel. The remaining 0.0000000009% is held by a wholly owned Mexican entity controlled by Teléfonos de México, S.A.B. de C.V., a subsidiary of CGT. CGT also controls Telint and holds approximately 60.7% of its capital stock.

and ITC-214-19980813-00564, discussed above) to Latam. On the same day, Consertel transferred all of its ownership interest in Latam to Sercotel, a direct subsidiary of América Móvil. After the consummation of the transaction, América Móvil thus continues to control Latam and the international Section 214 authorizations it now holds.

Pursuant to 47 C.F.R. § 63.24(d), note 2, the transactions described above, a "Corporate reorganization that involves no substantial change in the beneficial ownership of the corporation," an "[a]ssignment or transfer from a corporation to a wholly owned direct or indirect subsidiary thereof," and an "assignment from a corporation to a corporation owned or controlled by the assignor stockholders without substantial change in their interests" are presumptively *pro forma* in nature. Thus, this two-step assignment and transfer of control is *pro forma* and the parties are providing notice within 30 days after the consummation of the transaction. Further, the *pro forma* assignment of Consertel's international Section 214 authorizations and the subsequent transfer of control of Latam will serve the public interest, convenience, and necessity by allowing Latam and its parent companies to structure their businesses and operations in the manner they deem most efficient.
