### **ANSWER TO QUESTION 13**

Transfer of Control was consummated on February 22, 2012 with transfer of control of RNK, Inc. to RNK, Inc. as debtor in possession and from Wave2Wave Communications, Inc. to Wave2Wave Communications, Inc. as debtor in possession pursuant to a chapter 11 bankruptcy proceeding filed February 17, 2012 in New Jersey. This application qualifies under the pro forma rules (Sections 63.03 and 63.24 of the Commission's Rules) as a non-substantial transfer of control as there was no change in ultimate control of any of the entities involved due to the transaction. RNK remains the wholly owned subsidiary of Wave2Wave, and the ownership interests in Wave2Wave were likewise unaffected by this transfer.
