Notification of the Pro Forma Assignment of the International Section 214 Authorization of Syniverse Technologies, Inc. to Syniverse Technologies, LLC

Pursuant to Section 63.24(f) of the Commission's rules,¹ the Commission is hereby notified that the international Section 214 authorization (File No. ITC-214-20050420-00154) of Syniverse Technologies, Inc. Syniverse LLC holds no international Section 214 authorizations other than the authorization that is the subject of this notification.

Answer to Question 11:

The entities that directly or indirectly hold a ten percent or greater interest in Syniverse LLC are the same as those disclosed in the previously approved 2010 application to transfer control of the authorization to Buccaneer Holdings, Inc. (see File No. ITC-T/C-20101112-00445). This direct and indirect ownership information is restated below, as well as illustrated in the organizational chart set forth in Exhibit A.

No other persons or entities hold a 10 percent or greater direct or indirect interest in Syniverse LLC.

Answer to Question 13:

Syniverse Inc. undertook an internal corporate reorganization on February 29, 2012 in which the company’s corporate form was changed from a corporation to a limited liability company. No substantial change in the beneficial ownership of the company occurred as a result of the reorganization. Accordingly, transaction is presumptively considered *pro forma*.⁷
