Means by which assignment has taken place

Pulse Mobile, LLC, assignor, is a wholly-owned subsidiary of parent company TeleGuam Holdings, LLC, assignee. Due to a corporate restructure which consolidates subsidiary companies under the parent company, the long distance operations of Pulse Mobile, LLC have been merged into TeleGuam Holdings, LLC where long distance service will now be provided. Pulse Mobile, LCC does not seek to retain 214 authorization as it has been merged into the surviving entity of TeleGuam Holdings, LLC.

This is a pro forma assignment which does not result in a change in the ultimate control or ownership of TeleGuam Holdings, LLC which remains wholly owned by AP Teleguam Holdings, Inc.
