Dear Ms. Dortch:

North State Telephone Company dba North State Communications (“North State”) and NC Tide Acquisition Company LLC (“NC Tide”), by counsel for New Cingular Wireless PCS, LLC (“New Cingular Wireless”), file this letter pursuant to Section 1.65 of the Federal Communications Commission’s (“FCC” or “Commission”) rules¹ to provide updated information for the above-referenced pending application for the partial assignment of international Section 214 authority (ITC-214-19960703-00293) (as it pertains to certain wireless customer accounts) from North State (which will be retaining its international Section 214 authorization and thus is not seeking to assign the entirety of its authorization) to NC Tide, ultimately to be held as a wholly-owned subsidiary of New Cingular Wireless. Specifically, NC Tide herein provides updated information with respect to the post consummation foreign carrier affiliations and interlocking directorates to that provided in Attachment 1 to the above-referenced partial assignment application.²

Post consummation, NC Tide will no longer be affiliated with AT&T Red Global Telecommunications Ltda., a carrier in Chile. The other foreign carrier affiliations remain unchanged.³

Also, in addition to the interlocking directorate information provided in Attachment 1 to the Partial Assignment Application (pages 6-7), the following persons are
