Re: Joint Notification Pursuant to Section 63.24(g) for Transfer of International Section 214 Authorizations to Debtor-In-Possession

Dear Ms. Dortch:

Otelco Inc. ("Otelco") and its direct and indirect wholly-owned subsidiaries as described in Section III of this letter (together the "Joint Applicants"), pursuant to Section 214 of the Communications Act of 1934, as amended (the "Act"), and Section 63.24(g) of the rules of the Federal Communications Commission ("Commission" or "FCC"), 47 C.F.R. § 63.24(g), hereby inform the Commission that on March 24, 2013, the Joint Applicants each filed a voluntary petition pursuant to Chapter 11 of the U.S. Bankruptcy Code. As a result, the Joint Applicants' international Section 214 authorizations are now under the control of each entity as debtor-in-possession.

In support of this Notification, the Joint Applicants provide the following information:

I. BACKGROUND AND DESCRIPTION OF TRANSACTION – ANSWER TO QUESTION 13

On March 24, 2013, the Joint Applicants each filed a voluntary petition under Chapter 11 of the U.S. Bankruptcy Code in the U.S. Bankruptcy Court for the District of Delaware. As a

result, the Joint Applicants' international Section 214 authorizations are now held by each entity as debtor-in-possession. ¹ Each entity as debtor-in-possession will continue to operate its respective business and manage its property in the ordinary course of business. Prior to the bankruptcy filing, Otelco received acceptance of the Joint Prepackaged Plan of Reorganization for Otelco Inc. and Its Affiliated Debtors, dated February 1, 2013 (as may be modified, amended or supplemented, the "Plan") by all classes entitled to vote on the Plan. A hearing on the confirmation of the Plan is currently scheduled for May 6, 2013. If the Plan is approved at the confirmation hearing, such approval would allow each entity to emerge from bankruptcy upon achieving the conditions to emergence set forth in the Plan. The facts of the prepackaged bankruptcy filings relevant to the FCC are set forth in Section IV of this letter.

II. DESCRIPTION OF THE APPLICANTS

Otelco is a publicly-held Delaware corporation located at 505 Third Avenue East,

Oneonta, AL 35121. Otelco is publicly traded on NASDAQ under the symbol "OTT" and on the
Toronto Stock Exchange under the symbol "OTT.un." Through its wholly-owned subsidiaries,

Otelco is a full-service telecommunications provider and offers a wide array of communications
services including local exchange, long distance, Internet, broadband services, and cable
television in areas of Alabama, Maine, Massachusetts, Missouri, New Hampshire, Vermont, and
West Virginia. Otelco is the direct parent of ten LECs serving rural areas of Alabama, Maine,
Massachusetts, Missouri, Vermont, and West Virginia; and the direct parent of two CLECs
operating in Maine, Massachusetts, and New Hampshire. Otelco is the direct parent of two

interexchange carrier ("IXC") affiliates serving customers in a number of its LEC service areas.² A corporate organization chart of Otelco is provided to the Commission for its convenience at Appendix A. Notification for the Joint Applicants' transfers of control will also be filed with the Wireline Competition Bureau for the Joint Applicants' domestic Section 214 authorizations.

All applicants are wholly-owned subsidiaries of Otelco. See Section II for a description of Otelco. No single shareholder holds ten percent or more of the equity or voting stock of Otelco.

The Joint Applicants hereby certify that the transfer of control was *pro forma* and that, together with all previous *pro forma* transactions, does not result in a change in the actual controlling party.

IV. INFORMATION ON OTELCO INC. POST-BANKRUPTCY

The Plan enables the Joint Applicants to reduce their debt leverage and better position the Joint Applicants to compete in the telecommunications and information technology industry. When Otelco and its direct and indirect wholly-owned subsidiaries emerge post-bankruptcy, all of Otelco's existing equity will be cancelled. In its place, approximately 85.5 percent of Otelco's post-bankruptcy equity will be held by its pre-bankruptcy equity holders. Approximately 92.5 percent of Otelco's post-bankruptcy equity will be held by a combination of Otelco's pre-bankruptcy equity holders and holders of 13-percent senior subordinated notes due 2019 issued by Otelco, Inc. No person or entity will hold ten percent or more of post-bankruptcy Otelco's equity. As such, no single shareholder, through voting rights or equity, will control Otelco either before or after the bankruptcy and emergence from bankruptcy. Otelco's post-bankruptcy Board

of Directors, like the pre-bankruptcy Board, will comprise seven members. The Chief Executive Officer ("CEO"), Michael Weaver, will remain as CEO and retain his seat on the Board. The Joint Applicants anticipate that the Plan proposed by Otelco will provide that three of the other six board members will be re-appointed to their positions on the Board, so a total of four of the seven board members are expected to remain in place after emergence from bankruptcy.³ The Plan is expected to provide that three new board members will be appointed for Otelco's postbankruptcy Board.

Thus, under the Commission's rules, the corporate reorganization of the Joint Applicants under the Plan and their subsequent emergence from bankruptcy will not involve a change in the Joint Applicants' ultimate ownership or control, and will involve no substantial change in the ownership or control of Otelco and will, therefore, be a *pro forma* transfer of control. That being the case, a post-bankruptcy filing will be made by the Joint Applicants, as required pursuant to 47 C.F.R. §§ 63.24(d) and (f), with the International Bureau. The Joint Applicants will notify the International Bureau of any change to Otelco's emergence post-bankruptcy that differs from the information provided here. A filing will also be made with the Wireline Competition Bureau to notify the Wireline Competition Bureau of the bankruptcy filing as required by Section 63.03(d)(2).




