Post-Merger Ownership of the Parties

Globalcom Inc. will cease to exist following the completion of the *pro forma* merger with and into FCL.

First Communications, LLC's ownership will be unchanged and remain the same as the Pre-Transaction ownership.

Answer to Question 13.Description of the *Pro Forma* Transaction:

As part of its effort to streamline its corporate structure, First Communications, LLC (“FCL”) merged Globalcom, Inc. (“Globalcom”) into FCL on July 31, 2013, with FCL as the surviving entity. Globalcom previously adopted the fictitious name of First Communications and currently provides service to customers under the First Communications name. Accordingly the transaction will be virtually transparent to the customers of Globalcom. The merger will not result in a change to any aspect of a customer’s services, including the rates, terms and conditions, the format of their bills, and their customer service contacts including the toll free numbers. Prior to the merger Globalcom and FCL shared the same officers and used the same sales and customer service teams. The merger and change in control are *pro forma* and will not result in the actual controlling party of either party, except that Globalcom will cease to exist upon completion of the merger with FCL.
