Dear Ms. Dortch:

Last Mile USA, LLC (“Last Mile USA”) by counsel and pursuant to 47 C.F.R. 63.24(e)(4), hereby notifies the Federal Communications Commission (the “Commission”) of a decision not to consummate a transfer of control transaction.

Specifically, by Application dated August 24, 2014, Last Mile Corp. (“Last Mile Corp.”) and Last Mile USA sought Commission authority to transfer control of international section 214 authorization from Last Mile Corp. to Last Mile USA. The Commission approved the transfer of control Application on June 29, 2015.¹ Accordingly, Last Mile Corp. and Last Mile USA were authorized to complete the transfer of Last Mile Corp.’s international section 214 authorization.

Last Mile Corp. and Last Mile USA have decided not to consummate the transfer of control. Accordingly, Last Mile USA submits this notice to inform the Commission that Last Mile Corp. remains the holder of the International 214 authority (ITC-214-20130422-00112).
