Dear Ms. Dortch:

American Georgetown, Inc. (“AGI”) hereby files this supplement to the above-reference application (the “Application”).¹ AGI is the holder of an International Section 214 Authorization, File No. ITC-214-20061017-00476 (the “Authorization”). As referenced in the pending domestic Section 214 application (*see* Public Notice, WC Docket No. 15-134, DA 15-724, released June 22, 2015), upon consummation of a planned transaction, AGI will be transferring all of the issued and outstanding common stock of AGI’s wholly-owned subsidiary, Georgetown Telephone Company, Inc. (“GTC”), to KCL Enterprises, Inc. As part of this transaction and as reflected in the pending Application, upon consummation of the transaction AGI will also be assigning the Authorization to KCL.

As the Commission’s records reflect, GTC operates under the Authorization. GTC is the sole retail provider of services using the Authorization and has the customer relationship with all end users. Because GTC currently has the retail service relationship with its end user customers, no customer accounts will be retained by AGI. Upon the assignment of the Authorization, AGI


