Means by which assignment has taken place

Tomorrow Valley Communications, LLC (Tomorrow Valley), Assignor, is a wholly-owned subsidiary of parent company Amherst Telephone Company (Amherst), Assignee. Pursuant to a distribution of assets agreement, the long distance operations of Tomorrow Valley have been merged into Amherst where long distance service is now provided. Tomorrow Valley does not seek to retain 214 authorization as all long distance service is now provided by Amherst.
