APPLICATION FOR CONSENT  
TO ASSIGN INTERNATIONAL AUTHORITY

Global Freedom Telecom LLC ("Global Freedom" or "Transferor") and Wi-Live Avanza, Corp ("Wi-Live Avanza" or "Transferee") herein collectively called the "Applicants" pursuant to Section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214 *et. al.* (1982), and Section(s) 63.03 and 63.24 of the Federal Communication Commission's (hereafter called "Commission") Rules<sup>1</sup>, seek the Commission's Consent to Assign the Authority of Global Freedom under ITC-214-20140905-00262 to Wi-Live Avanza. Global Freedom was issued international authority from the Commission on September 26, 2014 and had the intent of commencing operations shortly thereafter. Lamentably, the plans of Global Freedom did not come to fruition, and, Global Freedom never provided any telecommunication services under its authority. Global Freedom now is in the process of liquidating its assets and closing the company. Global Freedom and Wi-Live Avanza have come to terms on an agreement wherein Wi-Live Avanza would purchase select asset of Global Freedom, and, be assigned Global Freedom's authority under a transaction where Global Freedom could liquidate remaining debt and close the company. The assignment of the authority will take place immediately on the Consent of the Commission. Wi-Live Avanza has not previously sought authority from the Commission to provider international services

pursuant to 47 U.S.C. § 214. Wi-Live Avanza has no foreign affiliations with foreign or dominant carriers. By granting this application, the Commission will serve the public interest, convenience and necessity by promoting competition in the international services market. Competition will benefit U.S. consumers by increasing service options and lowering prices. Furthermore, the approval of the assignment will not result in any change of service to the public insofar Global Freedom is not, and has not been, an operating international carrier. Thus, the public interest will be served by the grant of transfer and assignment of these customers from Transferor to Transferee.

## I. INTRODUCTION:

### A. Summary of the Contemplated Transaction

The Transferor, Global Freedom, will sell and assign select assets to Wi-Live Avanza, including the assignment of its international authority under ITC-214-20140905-00262 at a purchase price enabling it to liquidate debt associated with its failed upstart. Global Freedom has not commenced any telecommunications services. So no telephony customers or telecommunications contracts are involved with this transaction. The transaction is subject to the Commission's approval of the assignment. Wi-Live Avanza has secured adequate facilities to commence and operate telecommunications services post-assignment. The assignment of authority only contemplates Global Freedom's international authority, and Wi-Live Avanza shall secure its own FRN and FCC Form 499-A filer ID for future regulatory reporting and paying contributions to applicable regulatory mechanisms. Upon completion of this transaction, with the Commission's Consent, Global Freedom shall liquidate all debts, and be dissolved as a corporate entity with the State of Florida.

### B. Request for Streamlined Processing

The Applicants respectfully submit that this Application is eligible for streamlined processing pursuant to Section 63.03 and Section 63.12 of the Commission's Rules, found at 47 C.F.R. § 63.03 and 47 C.F.R. § 63.12, respectively. This Application is eligible for streamlined processing pursuant to Section 63.03(b)(2)(i) because, immediately following the transactions: (1) Transferor and Transferee hold less than a ten percent (10%) share of the interstate and/or interexchange market; (2) No dominant local exchange carriers are parties to the proposed transaction; and (3) Neither the Applicants are, or will be, dominant with respect to any service. This Application further qualifies for Streamlined treatment pursuant to 47 C.F.R. § 63.12 as Wi-Live Avanza is not affiliated with a dominant foreign carrier, and will not become affiliated with a foreign carrier as a result of this transaction. Furthermore, the provisions of 47 C.F.R. § 63.12(c) do not apply in this instance.

In support of this Application, Transferee Wi-Live Avanza submits Application Attachments I and II, and, the Applicants herein provide the following information:

## II. DESCRIPTION OF THE APPLICANTS

### A. Wi-Live Avanza, Corp ("Transferee")

Wi-Live Avanza is a privately-held Florida Corporation with its principal offices at 4224 West 16 Ave, Hialeah, Florida, 33016. Wi-Live Avanza will provide telecommunications services in the form of International and Inter-exchange services in the state of Florida. The transaction contemplated herein will be the first services of Wi-Live Avanza as a telecommunications carrier. All of the services provided by Wi-Live Avanza will be competitive in nature and Wi-Live Avanza does not hold a dominant position in any market. The following individuals, directly or indirectly own at least 10 percent of the equity of Wi-Live Avanza: Mr. Jesus Concepcion holds 30% equity in Wi-Live Avanza. Mr. Concepcion is a Cuban national who lawfully resides in the State of Florida. Mr. Luis E Bautista Gallangos holds 30% equity in the Company, Jose Guadalupe Villatoros Robles holds 30% equity in the Company. Mr. Gallangos and Mr. Robles are both Mexican nationals and residents. Ruben Dominguez Suarez holds 10% equity in the Company. Mr. Dominguez is a Cuban national who lawfully resides in the State of Florida.

### B. Global Freedom Telecom LLC ("Transferor")

Global Freedom is a privately-held Florida corporation with its principal offices at 1975 West 44 Place # A-304 Hialeah, FL 33012 USA. Global Freedom has held the Commission's authority to provide international services since 2014.<sup>2</sup> It is comprised of one shareholder who serves as the management of Global Freedom. Mr. Omar Lugo, a U.S. citizen residing in the state of Florida, owns 100% of Global Freedom and no other individual or entity holds a 10% or greater interest in Global Freedom Telecom LLC .

## III PUBLIC INTEREST CONSIDERATIONS:

As previously stated, the Applicants believe that the added competition this Assignment will bring to the market will benefit the consumers of United States-international telecommunications services, and specifically those in the State of Florida. This includes competitive pricing of services and increased availability of a variety of innovative service options. Therefore, the grant of this Application will further the public interest.
