As per the request of Staff, the Ignition Wireless, LLC ("Ignition"), and Mobile Net POSA, Inc. d/b/a Expo Mobile and Jolt Mobile ("Mobile Net"), hereby amend their Application (File No. ITC-ASG-20151210-00299) to state the following:
