### **Answer to Question 20**

This Application qualifies for streamlined processing pursuant to Section 63.12 because the Applicants are not affiliated with any foreign carriers; are not affiliated with any dominant U.S. carriers whose international switched or private line services the Applicants seek authority to resell; and do
