JOINT APPLICATION

Great Lakes Comnet, Inc.-*Debtor in Possession* ("GLC") and Everstream GLC Holding Company LLC ("Everstream")(collectively "Joint Applicants"), pursuant to § 214 of the Communications Act of 1934, as amended, 47 USC 214, and §§ 63.04 and 63.24 of the Federal Communications Commission's ("Commission") Rules, 47 CFR 63.04 and 63.24, hereby request approval of domestic and international § 214 authorization for the transfer of the Section 214 licenses held by GLC and its subsidiary, Comlink, L.L.C. ("Comlink") to Everstream. Information addressing the requirements of Commission Rule 63.04(a)(6) through (12) (47 CFR 63.04(a)(6) through (12)), is set forth in Attachment 1 to this Joint Application.

I. INTRODUCTION AND SUMMARY OF TRANSACTION

A. The Joint Applicants

Great Lakes Comnet, Inc.-Debtor in Possession

Great Lakes Comnet, Inc.-*Debtor in Possession* ("GLC") (FRN: 0003726270) is a privately-held Michigan corporation located at 1515 Turf Lane, Suite 100, East Lansing, Michigan, 48823. GLC has 16 shareholders, most of which are independent telecommunications providers that operate primarily in Michigan. Comlink, L.L.C. ("Comlink"), a wholly-owned subsidiary of GLC, is a Michigan Limited Liability Company located at 1515 Turf Lane, Suite 100, East Lansing, Michigan, 48823. A summary of the services provided by GLC and Comlink is set forth in **Attachment 1**.

Everstream GLC Holding Company LLC

Everstream GLC Holding Company LLC (FRN: 0025511759) is a Delaware Limited Liability Company that was formed on January 25, 2016, is a wholly-owned subsidiary of Everstream Solutions, LLC, and an indirect subsidiary of Everstream Holding Company, LLC. A summary of the services provided by Everstream is set forth in **Attachment 1**.

B. Summary of Transaction

On January 25, 2016, GLC and Comlink filed Voluntary Petitions for Reorganization under Chapter 11 of the Bankruptcy Code, *Re Great Lakes Comnet, Inc. and Comlink, LLC*, Case Nos. 16-00290 and 16-00292 (Bankruptcy Court, WD Mich)¹. On January 29, 2016, Everstream GLC Holding Company LLC entered into an Asset Purchase Agreement with GLC and Comlink to

acquire certain assets of both entities², and GLC and Comlink requested approval of the Bankruptcy Court for the sale. The Bankruptcy Court approved the sale at a hearing on May 10, 2016, and the Order was issued May 18, 2016.³ A copy of the Court's order approving the sale is set forth in **Attachment 2**.

Pursuant to the terms and conditions of the Asset Purchase Agreement, the closing of the purchase and sale is contingent on obtaining all required regulatory approvals, including the approval by the FCC of the transfer of GLC's licenses, which are among the assets being purchased. The parties are targeting closing the purchase and sale on May 27, 2016, subject to obtaining such approval.

On February 10, 2016, Great Lakes Comnet, Inc. filed an application for a *pro forma* assignment of its domestic and international authorization to Great Lakes Comnet, Inc.-*Debtor in Possession*, File No. ITC-ASG-20160219-00105. On May 11, 2016, the Commission granted approval of the assignment.

Pursuant to 47 CFR 63.24, Joint Applicants are seeking approval from the Commission for the transfer of the Section 214 licenses held by GLC and Comlink to Everstream GLC Holding Company LLC. If approved, Everstream represents that it will continue to provide high quality, affordable services that are uniquely tailored to the needs of existing and prospective customers. If this Joint Application is approved, Everstream represents that there will be no adverse effect on Everstream's ability to serve existing customers of GLC and Comlink. Joint Applicants submit that granting this Joint Application is in the public interest.

authorization for global re-sale service. GLC's wholly-owned subsidiary, Comlink, provides

international toll service pursuant to GLC's § 214 authority.

Everstream Holding Company, LLC (ITC-214-20160120-00027) holds international § 214

authorization for global re-sale services.

Everstream GLC Holding Company was granted Special Temporary Authority by the Wireline Competition Bureau on May 23, 2016, and by the International Bureau on May 26, 2016.

MA, is a domestic investment fund partnership and has an 80% direct equity ownership of Everstream Holding Company, LLC. Everstream GLC Holding Company LLC is an indirect subsidiary of Everstream Holding Company, LLC.

As evidenced by the certification attached to this Joint Application, Brett Lindsey certifies that Everstream Solutions, LLC and Everstream GLC Holding Company LLC do not, directly or through any affiliate, seek to provide international telecommunications services to any destination where: (1) Everstream Solutions, LLC or Everstream GLC Holding Company LLC is a foreign carrier in that country; or (2) Everstream Solutions, LLC or Everstream GLC Holding Company LLC company LLC controls a foreign carrier in that country; or (3) any entity that owns more than 25% of Everstream Solutions, LLC or Everstream GLC Holding Company LLC, or that controls Everstream Solutions, LLC or Everstream GLC Holding Company LLC, or that controls everstream Solutions, LLC or Everstream GLC Holding Company LLC, controls a foreign carrier in that country; or (4) two or more foreign carriers (or parties that control foreign carriers) own, in the aggregate, more than 25% of Everstream Solutions, LLC or Everstream GLC Holding Company LLC and are parties to, or the beneficiaries of, a contractual relation (i.e. a joint venture or market alliance) affecting the provision or marketing of international basic telecommunications services in the United States.

(k) Showing of WTO membership for destination countries.

from a foreign carrier or administration with regards to traffic or revenue flows between the United

States and any foreign countries the companies are authorized to serve.

(o) Certification pursuant to 47 CFR 1.2001 through 1.2003 that no party to the Application is subject to a denial of Federal benefits pursuant to section 5301 of the Anti-Drug Abuse Act of 1988.

pursuant to 47 CFR 1.2001 through 1.2003, that no party to the Joint Application or any affiliates

thereof, is subject to a denial of Federal benefits pursuant to §5301 of the Anti-Drug Abuse Act of

This Application is eligible for streamlined processing under § 63.12 of the Commission's Rules, 47 CFR § 63.12, because none of the exceptions to streamlined processing specified in (1) through (3) of § 63.12(c) applies.

III. <u>PUBLIC INTEREST STATEMENT</u>

The transaction described herein serves the public interest, convenience and necessity. GLC and Comlink have used state-of-art technology to meet their customers' sophisticated communications needs. Everstream GLC Holding Company LLC will continue to provide high quality telecommunications services to both existing customers of GLC and Comlink and prospective customers. The transaction has no adverse impact on customers, and will not trigger any rate increases. As the Joint Applicants are relatively small entities, the transaction has not and should not lead to the concentration of any market share, nor will it present any anti-competitive issues, or eliminate a competitor. If this Application is granted, Everstream GLC Holding Company LLC will continue to provide services to GLC and Comlink's customers without change or interruption, and the transfer of control will have no impact on their customers. As such, Joint Applicants submit that granting this Joint Application is in the public interest.

V. <u>CONCLUSION</u>

As demonstrated in this Joint Application, Joint Applicants submit that the public interest, convenience, and necessity would be furthered by a grant of this Application.
