Pursuant to discussions with FCC Staff, this filing is being submitted on behalf of Great Lakes Comnet, Inc.-Debtor in Possession ("GLC"), and Everstream GLC Holding Company LLC ("Everstream")(collectively, "Joint Applicants") in relation to the Joint Application filed in WC Docket 16-156/IB File No. ITC-214-1997-011600027. Specifically, this filing is being submitted to amend the Joint Application in order to include certain information required by the FCC Staff ("Staff").

As requested by Staff, the amended Joint Application included in this filing includes the ownership interest of Everstream, M/C Partners VII, L.P, a Delaware limited partnership, which has an 80% *direct* equity ownership in Everstream GLC Holding Company LLC. As indicated in Attachment 1, no person owns a 10% or greater equity interest in M/C Partners VII, L.P., all
